**OTHER FEES:**

- Registration Fee (compulsory) €750 p.a.
- Parents/Guardians Association subscription (compulsory) \*<sup>1</sup> €50 p.a.
- IB PYP Administration Fee (compulsory) €400 p.a. (5 instalments: Oct.-Feb.)
- Optional Extended Day Programme (Homework Supp./Act./Clubs) \*<sup>2</sup> €3,200 p.a. (2 instalments: Sep. & Jan.)
- Optional Lunch (13:20-13:45, five days per week) €950 p.a. (5 instalments: Oct.-Feb.)
- Optional Breakfast (07:00-07:40, five days per week) €630 p.a. (5 instalments: Oct.-Feb.)
- Excursions (compulsory) \*<sup>3</sup> €125 (1 instalment: Sep.)
- GL Assessment (compulsory for Years 2, 3, 4, 5 and 6):
  - NGRT €15 p.a. (1 instalment: Sep.)
  - PASS €8 p.a. (1 instalment: Sep.)

**NOTES:**

1. On Registration the following are payable (total €3,000):
  - Registration Fee €750
  - Parents/Guardians Association subscription €50
  - Towards the annual Tuition Fees €2,200
2. The balance of the annual Tuition Fees is payable in 6 equal instalments (September-February)
3. \*<sup>1</sup> Parents/Guardians Association subscription:
  - €50 per family for 1 child
  - €20 additionally per family per sibling
  - Parents/Guardians Association subscription for any other PASCAL School is paid separately.
4. Sibling discount of €500 is given on the Tuition Fees of each of the older children.
5. Parents/guardians of continuing pupils are required to reserve places for the upcoming academic year by 30<sup>th</sup> January 2026. Places must be reserved during the period stipulated with the amount of €1,000 (Reservation Fee). This amount will be deducted from the total amount of €3,000 which is payable on registration for the upcoming academic year (see note 1 above).
6. \*<sup>2</sup> Optional Extended Day Programme: The regular school day consists of 7 teaching periods. Pupils may choose to follow Homework Support, Afternoon Activities and Afternoon Clubs every day (5 days/week) after the end of the regular school day. The annual fees are:
  - Homework Support €1,000 13:45-14:45
  - Afternoon Activities €900 14:45-15:45
  - Afternoon Clubs €1,300 16:00-17:45

7. \*<sup>3</sup> Excursions: The excursions charge relates to the transportation and entrance cost only. Any other related costs (e.g. food & beverage) are payable separately.
8. The cost for the school uniform, the books (excluding the ones provided for free by the Cyprus Ministry of Education, Sport and Youth), the school transportation and the participation in the extra-curricular activities, such as competitions, conferences, etc. is not included in this pricelist. More information regarding these costs can be obtained from the school reception.
9. The fee for the external examinations, other than GL Assessment, depends on the subject/level/examination body and is charged separately.
10. Fees can be settled via debit/credit card, JCC Smart, wire transfers, monthly instalments by debit/credit card or standing order.
11. Tuition and other fees are reviewed annually. Any possible increment on the Tuition Fees and the Registration Fee has a cap of 8% on the fees of each Year for an academic year.
12. Reservation Fee (for continuing and new pupils), Registration Fee, Tuition Fees, Parents/Guardians Association subscription, IB PYP Administration Fee, GL Assessment and Excursions are not refundable or transferable under any circumstances as they guarantee (represent a deposit) a pupil's attendance at school for at least one academic year. Hence, this is not simply an advance fee payment.
13. The inability to continue with school lessons, for whatever reason, does not exempt the parent/guardian from the obligation to pay the school fees for the whole academic year. Any balance of fees due upon the departure of a pupil from the school, irrespective of the date of the departure, must be paid in full. In the event that fees of a pupil were paid in full and the pupil ceases to attend the school, no refund is applicable. The departure of any pupil in no way minimizes the school's running costs.
14. The school has the right to withdraw scholarships, monetary prizes or discounts in case the fees are not paid by the applicable instalment deadline.
15. The Disciplinary Committee has the right to recommend the withdrawal of scholarships, monetary prizes and/or discounts in case of serious disciplinary incident or disciplinary code infringement.
16. For those pupils whose fees are met partially or in total by the Cyprus Government (such as Maronites, Armenians, Latins, repatriated Cypriots, Turkish Cypriots and so on), it is the obligation of their parents/guardians to settle the school fees according to the applicable deadlines irrespective of when the subsidy is received from the Government.
17. Enrolment in the subsequent academic year will be accepted only once the due fees and other financial obligations have been settled.
18. In accordance with current legislation (The Prevention and Combating of Money Laundering Act of 2007 (188(I)/2007), the school is not permitted to accept cash payments exceeding €10,000 per family, per academic year, regardless of the number of children enrolled. This applies to all financial transactions between the school and families, such as tuition and other fees, activities, external examinations, excursions and books (with the exception of the school canteen).
