- The underground boiler line at Longfellow school has had recent repairs done to it and should be completed by November 21 weather permitting.
- We have been in talks with the district architect and engineer in determining what projects we want to focus on for summer 2026.
- New drinking fountains and bottle filling stations continue to be installed in areas throughout the district.
- Four new modine heaters are scheduled to be installed in Washington School's east gym.
- Updated energy lighting will start to be installed at MHS and Adams school along with new exterior lighting added to some buildings.
- Staff Training and team communication continue with both the Maintenance and Custodial departments.
