### Early Childhood (Infants-3's)

The Application Fee along with the Tuition Deposit are non-refundable. The Tuition Deposit is due on February 18<sup>th</sup> and is applied to the annual tuition. A Facilities Fee is assessed annually to each family and is due with the first tuition payment. All tuition payments will be set up through FACTS Management System. See Tuition Payment Options below. Tuition includes morning and afternoon snacks with juice, daily lunch with milk, art and paper supplies, educational curriculum materials, and special outsourced programs. Additional fees separate from above, including but not limited to school supplies, after school clubs and activities, and extended learning program fees may be assessed per student.

### Elementary & Middle School (PreK-7th)

The Application Fee along with the Tuition Deposit are non-refundable. The Tuition Deposit is due on February 18<sup>th</sup> and is applied to the annual tuition. A Facilities Fee is assessed annually to each family and is due with the first tuition payment. The Technology Fee is also due with the first tuition payment. All tuition payments will be set up through FACTS Management System. See Tuition Payment Options below. Additional fees separate from above, including but not limited to school supplies, lunch, beverages, novels, after school clubs and activities, and extended learning program fees may be assessed per student.

### Tuition Payment Options

Plan A: Advance Payment Plan - All tuition (subject to a credit for the deposit) will be paid in full on or before April 1st, in consideration of which Cedarwood will grant a two percent (2%) discount on the tuition owed.

Plan B: Annual Payment Plan - All tuition (subject to a credit for the deposit) will be paid in full on or before July 1st.

Plan C: Semi Annual Payment Plan - All tuition (subject to a credit for the deposit) will be paid in 2 equal payments, with the first installment due on or before July 1st and the second installment due on or before December 1st.

\*Plan D: 10 Month Payment Plan - All tuition (subject to a credit for the deposit) will be paid in 10 equal payments due on or before the 5th of each month from July through April.

### Discounts

A two percent (2%) tuition discount is extended for payment of tuition in full by April 1st. A five (5%) percent sibling discount is offered through the finance office for multiple students of the same family.

### Delinquent Accounts

An interest charge of one and one-half (1.5%) percent per month (or any portion thereof) until paid shall be assessed on all late payments. A seventy-five (\$75) dollar service charge shall be assessed on all non-sufficient checks and payments. Interest and service charges shall be charged and paid with the next payment made through FACTS.
