

Title I Parent and Family Engagement Policies

Part I – School Parent and Family Engagement Policy

- In-person and virtual parent-teacher conferences are made available to parents to provide options and flexibility.
 - Home visits are provided to the family on behalf of the school by the Family Liaison to assess barriers to attendance and provide support when the student has missed over 5 days.
 - Parents will be afforded the opportunity to meet with teachers and administration flexibly during school hours by setting appointments with the admin according to the schedule, and with teachers during their planning periods, in addition to after-school hour appointments via scheduling
- D. Involve parents, in an organized, ongoing, and timely way, in the planning, review, and improvement of the school plan under Section 1112, schoolwide under Section 1114, and the process of the school review and improvement under Section 1116.

- Parent feedback is thoughtfully captured and analyzed to strengthen the school's improvement plan at each Title I family Engagement session.
 - Parent feedback is thoughtfully captured and analyzed to strengthen the school's improvement plan through annual parent satisfaction surveys administered by the Office of Engagement.
 - PTA will distribute a "satisfaction of community events and opportunities" survey to all student caregivers.

 - Consistent and effective call and home visit outreach strategy performed by the Family Liaison
 - If there is a language that cannot be interpreted by Fox staff, Fox will use the RPS contracted vendor, United Language Group, to communicate in a language that parents can understand.
 - Caregivers are invited to review their students' LIEP plans for recommendations and understanding.
- F. Provide parents of participating children—
- timely information about programs under this part;
 - a description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the proficiency levels students are expected to meet;
 - If requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practically possible.
 - Fox staff will provide timely information to parents about school community programs electronically via Parent Square.
 - Opportunities for parents to participate in regular meetings in order to formulate suggestions and participate where appropriate, in decisions relating to the education of their children will be scheduled by teachers and school counselors, both by the teacher and counselors' discretion and by scheduled dates from the school calendar provided to all parents at the beginning of the school year.
 - Every week, the principal and teachers send out correspondence about upcoming events, students' learning objectives, and testing schedules.
- G. If the schoolwide program plan is not satisfactory to the parents of participating children, submit any parent comments on the plan when the school makes the plan available to the LEA.—
- Collect written or verbal comments from parents during PFEP workshops, parent–teacher conferences, and any scheduled Title I events.
 - Document all parent participation through sign-in sheets.
 - Review concerns with the school administration and Title I team within ten school days to determine necessary revisions or follow-up.

- Share updates with families via ParentSquare, the school website, and printed notices to ensure transparency in the revision process.

Part II – Building Capacity for Parents and Staff

- To ensure effective involvement of parents and to support a partnership among the school, parents, and the community to improve student academic achievement, each school and LEA must:
- Assist parents in understanding the challenging State academic standards, how to monitor a child's progress, and work with educators.
- Fox hosts SOL Night for parents, where they are made abreast of information about SOL testing and how to assist in preparing students for the tests. They are also provided with academic resources to assist.
- During the annual Back to School Night program, annual Title 1 meetings, literacy workshop, and math workshops
- Principal conferences about student needs and progress with individual families. From the conference, the Principal and family will develop a learning plan together.
- Parents are able to meet with school staff, including teachers and admin, via appointment during planning or after school hours to discuss students' progress.
- Provide materials and training to help parents to work with their children, such as literacy training and using technology (including education about the harms of copyright piracy).
- Parents have been/will be provided with materials and techniques to support strategies to strengthen students' reading fluency and comprehension.
- Parents will be surveyed to gather suggestions about future workshops to be held.
- Provide professional development to teachers, specialized instructional personnel, and other staff on the value of parents and their communities to increase academic achievement.
- Any staff training on parental engagement takes place during the weekly staff development meetings during PLC's and staff development meetings.
- The Title I staff at Fox takes part in all parental engagement activities during the week.
- Coordinate and integrate parent engagement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parent engagement.
- The Family Liaison works collaboratively with agency Communities In Schools to plan and execute ongoing parent and family engagement activities and events.
- Fox will work with the feeder preschool center to ensure students are prepared to transition to Elementary school.

- In collaboration with CIS, students will participate in transition sessions for rising 6th-grade students
- Ensure that information related to school and parent programs, meetings, and other activities is sent to the parents of participating children in a format and, to the extent practicable, in a language the parents can understand.
- Fox staff will use Parent Square, which will translate into any language based on the family's needs.

The following are allowable activities:

- 1) May involve parents in the development of training for teachers, principals, and other educators to improve the effectiveness of such training.
- 2) May provide necessary literacy training from funds received under this part if the district has exhausted all other reasonably available sources of funding for such training. (List actions)
 - Fox may provide necessary literacy training for parents using Title I funds if all other reasonably available sources of funding have been exhausted. Actions include:
 - Parent Literacy Workshops: Offer workshops focused on strategies to support reading and writing at home, including helping students with SOL preparation, reading comprehension, and writing skills.
 - Family Literacy Nights: Host evening sessions where parents can practice literacy strategies
 - Family Math Nights: Host evening sessions where parents can practice Math Skills.
- 3) May pay reasonable and necessary expenses associated with local Parent and Family Engagement activities, including transportation and childcare costs, to enable parents to participate in school-related meetings and training sessions. (List actions)
 - Fox will use Title I funds to provide resources for school-based parent engagement activities.
- 4) May train parents to enhance the involvement of other parents. (List actions)
 - Monthly board meetings will be used for ongoing professional development around family engagement and cultural awareness.
- 5) May arrange school meetings at a variety of times, or conduct in-home conferences between teachers or other educators, who work directly with participating children, with parents who are unable to attend such conferences at school, in order to maximize Parent and Family Engagement and participation.  - Virtual Meeting Options: Provide virtual meetings via video conferencing platforms for parents who cannot attend in person.
 - Parent Appointment System: Implement a scheduling system allowing parents to request appointments with teachers, administrators, counselors, and Title I staff at times that best fit their availability.
