Narrative:

Average Daily Attendance (ADA)

LCFF revenue projection reflects projected ADA at 92% in the current year and 90% in the out-years. ADA has remained relatively flat during the post-pandemic period hovering over 90%, indicating limited evidence of sustained improvement to the pre-pandemic average of 94%. ADA has also been negatively impacted by federal political action impacting immigrant families.

The District’s Historical Average ADA-to-Enrollment Ratio is 90.3% which includes an audit adjustment in the third year (2022-23) lowering the average. While the projected P-2 ADA ratio in the current year temporarily exceeds the District’s historical standard, available data indicates that this increase is not yet supported by sustained long-term trends.

Therefore, using a conservative ADA ratio remains the most prudent approach to ensure LCFF revenue projections are realistic and fiscally sound. As of Month 3, ending October 31, 2025, the District’s ADA is 92.48%. The District must continue its ongoing efforts to maintain ADA at 92% or higher in order to support revenue stability. The District will continue attendance efforts and will adjust at Second Interim once more data is available.

Enrollment

Student Enrollment for 2025-26 school year dropped by approximately 5%. The pre-existing factors contributing to enrollment declines include falling birth rates, political impacts from the federal level on immigration and increasing cost of living. The trend of declining enrollment in public schools is a significant concern, over the last ten years Lynwood USD experienced a negative change of 30.5%. During 2015-16 the District served 14,830 and is now serving 10,311 students.

Intensified immigration enforcement has significantly impacted school enrollment for one of the largest school districts, this situation is concerning as it may have long term ramifications for public education and neighboring districts.

Budget Changes and Pressures

In response to the letter received on January 13, 2025, from the Los Angeles County Office of Education (LACOE), the District submitted a Fiscal Stabilization Plan (FSP) with its 2024–25 Second Interim Report to address ongoing deficit spending. As part of this plan, the District will implement the identified reductions, including the elimination of positions supported by one-time, expiring funds.

Projected increases include (1) Salary and Benefit Settlement Costs (2) Projected Adult Fund Contribution (3) continued increases in Special Ed expenditures.

In the out-years, projected decreases include reductions in accordance with our Fiscal Stabilization Plan (FSP) and expenditures funded with one-time funds.

In compliance with Education Code Section 42127, the District previously committed \$26.7M upon adopting the budget. This commitment serves three purposes, (1) Compliance with Ed Code, (2) address deficit spending, on-going retirement increases, liability exposures resulting from recent changes in legislation (i.e., SB558, AB4523, AB21) increasing the schools excess liability insurance costs, and (3) revenue reductions resulting from enrollment and ADA shifts. The District will take action to uncommit funds beginning 2026-27.

It is uncertain whether the Governor's budget assumptions will change resulting from tariffs and changes in immigration policy. To protect the quality education of our students, it is imperative to maintain reasonable reserve levels to cover at least two months of salary expenses as recommended by the Government Finance Officers Association.

Conclusion

The pace of enrollment declines compounded with a flat trend of ADA is a critical warning sign for future revenue stability. Significant cost pressures will further strain resources. To maintain fiscal solvency and maintain a positive certification, further reductions ahead will be required.

Part IV - Carry-forward Adjustment

The carry-forward adjustment is an after-the-fact adjustment for the difference between indirect costs recoverable using the indirect cost rate approved for use in a given year, and the actual indirect costs incurred in that year. The carry-forward adjustment eliminates

the need for LEAs to file amended federal reports when their actual indirect costs vary from the estimated indirect costs on which the approved rate was based.

Where the ratio of indirect costs incurred in the current year is less than the estimated ratio of indirect costs on which the approved rate for use in the current year was based, the carry-forward adjustment is limited by using either the approved rate times current year base costs, or the highest rate actually used to recover costs from any program times current year base costs, if the highest rate used was less than the approved rate.
