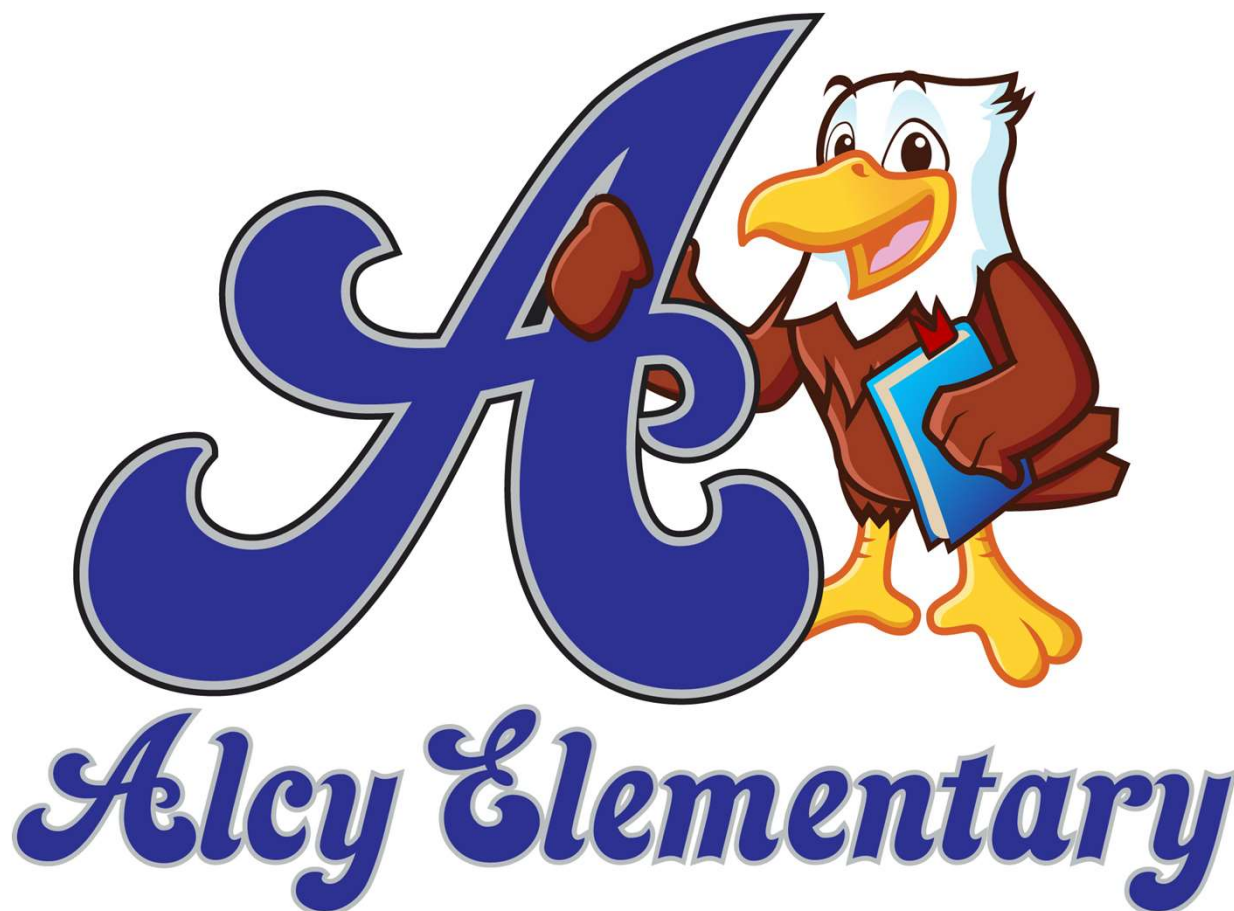

Title I School Status

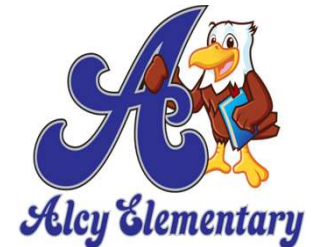


Alcy Elementary School is a federally funded Title I school.

Based on the school's Title I status, the entire student body receives free breakfast and lunch.

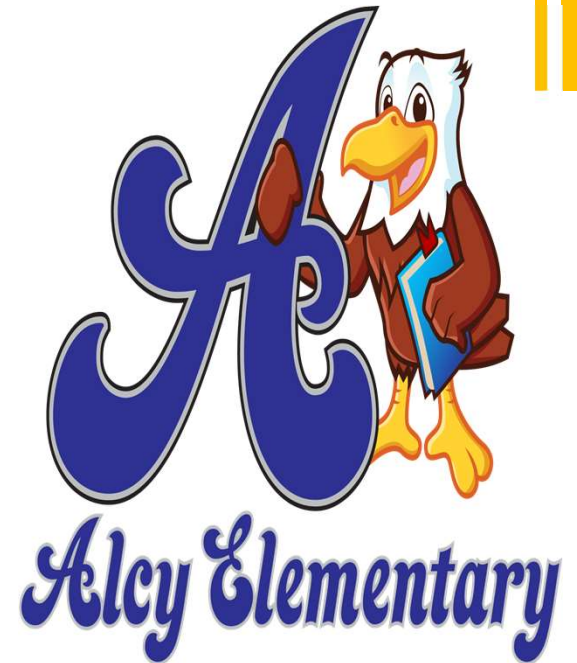




FAMILY ENGAGEMENT PLAN

Alcy Elementary has a special responsibility to our parents and the community to provide opportunities for involvement and shared responsibility which will promote success for all students.

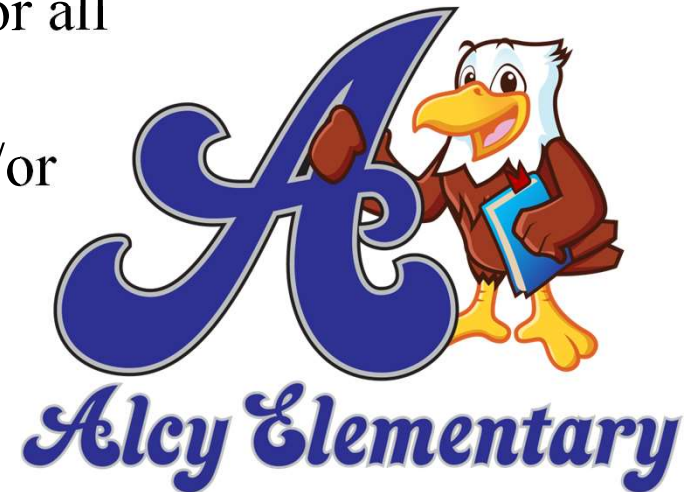
Our parental involvement policy at Alcy Elementary School was incorporated jointly with our parents and is revised annually.

PARENT' S RIGHT TO KNOW



All parents have the right to request the following:

- ▶ A teacher' s professional qualifications, licensure, grade(s) certification, waivers
- ▶ A teacher' s baccalaureate and/or graduate degree, fields of endorsement, previous teaching experience
- ▶ A paraprofessional' s qualifications
- ▶ An annual notice of Student Education Records Privacy and notice for disclosure of School Directory Information
- ▶ An assurance that their child' s name, address and telephone listing not be released to military recruiters

All parents will receive information on the following:

- ▶ Their child' s level of achievement on each of the state's academic assessments
- ▶ Notification of right to transfer their child to another school in the district if the student becomes the victim of a violent crime or is assigned to an unsafe school
- ▶ District Family Involvement Policy and School Parent Involvement Policy
- ▶ Their right to public school choice, Supplemental Educational Services and more effective involvement if their child' s school is identified for school improvement .

TEACHER QUALIFICATIONS



- Alcy Elementary school teachers are “*Highly Qualified*” in their core subject area as mandated by section 1119 of the “No Child Left Behind” law. Non-certified teachers are enrolled in Teacher Education Programs for licensure.
- In the event that your child is taught for 20 days or more by a non “*Highly Qualified*” teacher you will receive the teacher’s status in writing.



WHAT IS THE SCHOOL IMPROVEMENT PLAN?

- ▶ It is a document of information containing:
 1. School demographics
 2. Student test scores
 3. Plans to improve the school

- ▶ It is a work-in-progress for the entire school year.
- ▶ A copy can be found on the school's website as well as a hard copy in the office for public viewing.
- ▶ Alcy Elementary School utilizes parent input when writing the School Improvement Plan. Parents are encouraged to be committee members in order to provide insight into the direction the schools will take to improve academic instruction.
- ▶ Parents can leave suggestions via school webpage or call the main office.



REPORTING PUPIL PROGRESS

- Alcy Elementary School reports student progress to parents in several ways:
 - Progress Reports which are issued once during a nine-week grading period (every 4 1/2 weeks)
 - Report cards issued every nine weeks
 - Parent teacher conferences (formal & informal)
 - Weekly school newsletter and information flyers
 - Telephone contact

Thursday, September 11, 2025 from 4-7pm

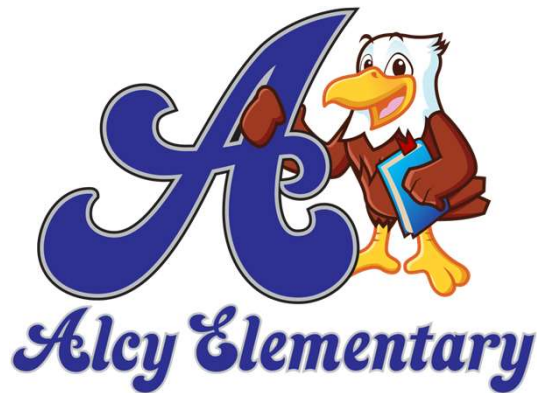
Thursday, January 29, 2026 from 4-7pm
