

ORDINANCE No. 2025-11

AN ORDINANCE TO AMEND THE SALARIES OF CERTAIN OFFICERS AND EMPLOYEES OF THE BOROUGH OF AUDUBON IN THE COUNTY OF CAMDEN, STATE OF NEW JERSEY.

WHEREAS, the Board of Commissioners of the Borough of Audubon find it appropriate to amend the salaries of several positions

with the Borough; and

WHEREAS, there are several positions for which an additional or amended salary is appropriate to account for the work being done by Borough employees in several positions; and

NOW THEREFORE, BE IT ORDAINED by the Board of Commissioners of the Borough of Audubon, County of Camden, State of New Jersey, as follows:

SECTION 1: AMENDMENT TO SALARY ORDINANCE 2025-08

Salary Ordinance 2025-08 is hereby amended to revise the following positions and compensation:

A. DEPARTMENT OF PUBLIC AFFAIRS AND SAFETY: Police Clerk

Add a stipend of **\$1,000.00** for purchasing responsibilities.

B. DEPARTMENT OF REVENUE AND FINANCE: Administrative Assistant

1. **Administrative Assistant** - Salary is hereby revised from \$42,142.00 to **\$44,141.24**.
2. **Part-time Tax Clerk** – Stipend of **\$1,000.00**

C. DEPARTMENT OF PUBLIC WORKS, BUILDINGS AND GROUNDS: Fire Marshal Inspector

Salary is hereby revised to reflect range from \$17,000.00 to **\$26,750.76**.

D. Zoning Officer (3)

Salary is hereby revised to reflect range from \$15,914.04 to **\$18,914.04**.

SECTION 2: EFFECTIVE DATE

All other provisions of Salary Ordinance 2025-08 shall remain in full force and effect. This Ordinance shall take effect upon final passage and publication as required by law are effective as of January 1, 2025.
