Gifts of securities, including appreciated stocks, bonds, or mutual funds, may provide special tax advantages. Our team can work with you and your advisors to develop a plan that meets your personal and philanthropic goals.

The Frederick Gunn School recommends giving stock through electronic transfer. Electronic transfer is the easiest method when a donor maintains holding in a brokered account. Depository Trust Company (DTC) is the clearinghouse for electronic security transfers.
