ACTION REQUESTED: APPROVE

TITLE AND SUBJECT: Approve the 2025/26 First Interim Financial Report

ITEM DESCRIPTION: Included in the Board material is Fresno Unified School District's 2025/26 First Interim Financial Report. California school districts are required to approve interim financial reports twice each fiscal year. Fresno Unified School District's 2025/26 First Interim Financial Report is presented for approval and reflects a positive certification of the district's financial condition. The report is based on the October 31, 2025 year-to-date revenue and expenditures as required by state law.

The Superintendent recommends approval of the First Interim Financial Report

FINANCIAL SUMMARY: A positive certification reflects that the district's projected reserve for 2025/26 at \$97.8 million exceeds the minimum required reserve for economic uncertainties (2%). Additionally, projections indicate a positive cash balance for the current year and two subsequent years. The support material reflects a multi-year projected budget for the Unrestricted General Fund and utilizes the State assumptions developed by the California County Superintendents Educational Services Association.

State Financial Reporting Requirements

The state requires school districts to submit interim financial reports twice a year. The First Interim is due by December 15 and the Second Interim by March 15. With these reports, school districts must certify their financial status for the current and two subsequent fiscal years. The certification status is classified as follows:

- Positive – will meet its reserve requirement and have a positive cash balance
- Qualified – may not meet its reserve requirement and/or may not have a positive cash balance
- Negative – will not meet its reserve requirement and will not have a positive cash balance

Fresno Unified School District has maintained a positive certification since 2006. However, a school district with a qualified or negative certification loses some of its financial autonomy. The district's collective bargaining agreements are subject to County Office scrutiny prior to board approval and the district is prohibited from incurring specific non-voter-approved financial obligations. In addition, qualified or negatively certified school districts must complete a Third Interim Report by June 1st.

Fresno County Superintendent of Schools (FCSS) First Interim Memo to School Districts

The FCSS provided guidance in October that outlined the assumptions school districts should follow while preparing their First Interim reports which includes:

- *“Maintains a 2.3% funded cost-of-living adjustment (COLA) to the Local Control Funding Formula (LCFF).”*
 - *“Includes a \$1.9 billion deferral of LCFF apportionments from June 2026 to July 2026.”*
 - *“Maintains investment of a total of \$2.1 billion in ongoing to support the full implementation of universal transitional kindergarten (TK). An additional \$1.2 billion was provided in ongoing funding to support lowering the average student-to-adult ratio from 12-to-1 to 10-to-1 in every TK classroom beginning in 2025-26.”*
 - *“Allocates \$1.7 billion in one-time Proposition 98 for the Student Support and Professional Development Discretionary Block Grant.”*
 - *“Declining enrollment, coupled with the expiration of federal one-time funds, may result in deficit spending for many school districts.”*
 - *“As fund balances potentially decline, districts must exercise caution when allocating resources for long-term commitments, including negotiated salary increases.”*
 - *“Economic trends also suggest that the LCFF COLA for 2026-27 could be lower than what is included in the LCFF planning factors.”*
 - *“The state budget continues to face increased risk due to changes in federal policy and funding, which may affect both revenues and expenditures. LEAs must navigate short-and long-term challenges, including volatility in the state revenue forecast, declining enrollment and attendance, rising pension costs, inflationary pressures, and the expiration of one-time funds.”*
- ✓ The CalSTRS employer contribution rates remained the same in 2025/26, 2026/27 and 2027/28 at 19.10%
- ✓ The CalPERS employer contribution rates remained the same as the May Revise at 2025/26 26.81%, 2026/27 26.90%, and 2027/28 27.8%.

Rationale for Positive Certification Status

Staff recommends a positive certification status. For purposes of this memo and analysis, the assumptions utilized include the provisions outlined in the FCSS memo. Also included are local assumptions, changes in benefit rates, indirect rates, and planned reductions. After consideration of these factors, the Multi-Year Report indicates that the district will maintain its required reserve and will maintain a positive cash balance.

Overall, the First Interim includes overall increased cost from the adopted budget of \$1.0 million.

Current and Future Year Factors

1. Local Control Funding Formula (LCFF) for 2024/25

The LCFF revenue is funded on prior year Average Daily Attendance (ADA) due to declining enrollment. The First Interim recognizes an increase of \$2.9 million in the following areas:

- 2024/25 prior year actual ADA an increase of \$400,000
- An estimated increase in the Unduplicated Pupil Percentage (UPP) from 87.90% to 88.90% and increase of \$2.1 million. The Second Interim will finalize the UPP
- Increased charter students returning to Fresno Unified in 2025/26 of 78 ADA charter ADA an increase of \$400,000

2. State Revenue

The First Interim recognizes reduction in transportation revenue due to lower costs in 2024/25 and shifts to after school grants of \$2.2 million.

3. Salary and Benefits

Included in the First Interim are savings in the Unrestricted General Fund of \$400,000 in salaries and benefits based on year-to-date expenditures compared to historic averages.

4. Supplies, Services and Capital Outlay

At this time, the First Interim projects all sites and departments will spend allocated funds, hence no change from budget.

5. Indirect Cost

The projected additional cost of \$2.1 million in the indirect line items is based on historical averages. For example, the district historically receives approximately 92% of the budgeted indirect cost rate due to grants not being completely spent by fiscal year end. The 2025/26 indirect cost rate is 6.19%.

6. Board of Education Designated Funds

At the June 18, 2025 and October 15, 2025 Board of Education meetings, one-time expenditures and carryover of one-time funds were approved.

One-Time Expenses

The First Interim projects \$55.4 million will be expended in 2025/26 in the following main areas:

- One-Time Salary 2.5% Salary Increase \$ 20.2 million
- FTA Student Support \$ 10.0 million
- Textbook Adoption \$ 8.1 million
- Designated Schools (phase out) \$ 6.0 million
- Learning Recovery Support \$ 5.2 million
- Lawson Upgrade \$ 2.7 million
- Education Center Remodel \$ 1.8 million
- Security Upgrades \$ 0.8 million
- Transportation Equipment \$ 0.6 million

One-Time Utilization of Grants

The First Interim projects \$45.1 million will be expended in 2025/26 in the following main areas:

- Educator Effectiveness Grant \$ 6.0 million
- Arts and Music Block Grant \$ 37.7 million
- Restricted Lottery \$ 0.4 million
- Health Fund Post Employment Contribution \$ 1.0 million

7. Local Control Funding Formula (LCFF) for 2026/27 and 2027/28

The multi-year projections include LCFF funding at the levels mentioned earlier in the report, resulting in an increase for 2026/27 and 2027/28 of \$25.1 million and \$27.2 million, respectively. The increased COLA will be partially offset by declining enrollment. The assumptions include a decline in enrollment in 2026/27 by 901 students and in 2027/28 a decline in enrollment by 1,115 students. TK expansion was fully implemented in 2025/26.

8. CalSTRS and CalPERS for 2026/27 and 2027/28

The multi-year projections include funding employer costs for CalSTRS and CalPERS at the levels mentioned earlier in the report, an increase for the General Fund of \$200,000 in 2026/27, and \$1.5 million in 2027/28.

9. Health Contribution for 2026/27 and 2027/28

In accordance with the current employee bargaining agreements, the 2025/26 district's health contribution level remains the same at \$22,000 per employee participant. In 2026/27, the health contribution will increase by the compounded base LCFF change from 2022/23 to 2026/27 at \$25,029 per employee participant and \$25,684 for 2027/28.

10. Indirect Rate for 2026/27 and 2027/28

The 2024/25 Unaudited Actual Financial Report projected the 2026/27 indirect rate at 6.37%. The multi-year projection assumes this rate through 2027/28.

11. Contributions for 2026/27 and 2027/28

Contributions for Special Education and Routine Restricted Maintenance are projected to increase for salary increases and statutory benefit costs in the multi-year by \$3.4 million for 2026/27, and \$2.1 million for 2027/28.

12. Other Post-Employment Benefits (OPEB)

The multi-year projection includes a \$0.5 million contribution from the Unrestricted General Fund for all years. Additionally, \$3.0 million is contributed from the Health Fund for a total of \$3.5 million annually. The OPEB reserve is estimated at \$98.5 million as of June 30, 2026.

Conclusion

A summary of all budgets is reflected in the attached state report. Staff recommends the Board approve the 2025/26 First Interim Financial Report with a positive certification as presented.

Part IV - Carry-forward Adjustment

The carry-forward adjustment is an after-the-fact adjustment for the difference between indirect costs recoverable using the indirect cost rate approved for use in a given year, and the actual indirect costs incurred in that year. The carry-forward adjustment eliminates
