



Bellevue School District Levy Renewals



Bellevue School District voters will consider two levy renewals in the February 10 election.

These measures are not new taxes—they replace expiring levies and bridge the gap between what the state funds and what our district needs to operate.

PROPOSITION 1

Educational Programs and Operations (EP&O) Levy

Proposition 1 continues funding for:



HIGH QUALITY TEACHING AND LEARNING

- Career and Technical Education (CTE) programs and facilities at middle and high schools
- Additional classroom staff
- 7 period day and tutorials at middle and high schools
- Science, Technology, Engineering, and Math(STEM) programs
- World languages in middle schools, Heritage, and dual language programs



STUDENT WELLBEING, SAFETY AND SUPPORTS

- Counselors, psychologists, nurses, and social workers
- Safety and security staff, training, and emergency planning
- Special education services
- Advanced classes including Advanced Placement (AP), International Baccalaureate (IB), and College in the High School



OPPORTUNITIES BEYOND THE CLASSROOM

- Orchestra, band, and music programs
- Athletics and activities
- Arts in elementary schools

PROPOSITION 2

Technology and Capital Projects Levy

Proposition 2 continues funding for:



SCHOOL SAFETY AND SECURITY

- Safety improvements to school buildings
- Safety and preparedness training for students, staff, and families
- Safety audits, threat assessments, and cybersecurity
- AEDs, cameras, and visitor management systems



BUILDING MAINTENANCE AND IMPROVEMENTS

- Roofing, carpeting, and heating/cooling systems
- Repairs and maintenance
- Updates to athletic facilities, including fields
- Kitchen improvements



CLASSROOM TECHNOLOGY AND LEARNING

- Access to updated technologies and software
- Integrated digital curriculum and collaborative STEM learning
- Classroom technology and professional development for educators
- A computer or tablet for every student
- Technology support including networks, cybersecurity, and tech assistance

Investing in Our Future World

Bellevue School District receives funding from state, federal and local funds. BSD uses voter-approved levies to help bridge the gap between what the state funds, and what it costs to operate our schools. The 2026 replacement levies renew funding that voters approved four years ago.

LEVY	ESTIMATED RATE	PURPOSE
Educational Programs & Operations Levy	\$0.75 per \$1,000 of assessed property value	Day-to-day school operations
Technology & Capital Projects Levy	\$0.54 per \$1,000 of assessed property value	Technology, safety, and facility upkeep

For a Bellevue home valued at \$1 million, the combined cost is about \$1,290 per year for Bellevue School District.

Our Financial Health is Improving

One year ago, BSD was in a difficult financial position and expected to face even more challenges in the year ahead. By cutting costs, working closely across schools and departments, and managing money carefully, the district's financial situation has improved. BSD is now ahead of schedule in meeting its financial requirements and is continuing to keep spending under control while rebuilding its savings.
