- C. _____ 12 equal payments of **\$750** beginning May 11, 2026 with the final payment due April 12, 2027.
- D. _____ 11 equal payments of **\$820** beginning June 10, 2026 with the final payment due April 12, 2027.
- E. _____ 10 equal payments of **\$900** beginning July 10, 2026 with the final payment due April 12, 2027.
- F. _____ 9 equal payments of **\$1,000** beginning August 10, 2026 with the final payment due April 12, 2027.

1. Payment is due on the **10th** of each month, unless otherwise stated. Payments received after the **20th** of each month will be subject to a \$50 late charge per month. Tuition past due 20 days or more may result in online accounts being locked, and the ineligibility of my son/daughter to remain at Juan Diego Academy.
2. There is a \$35.00 NSF fee for checks returned by the bank for insufficient funds. At the discretion of the administration, it may be necessary to require all future payments be made in the form of cash, money order, or cashier's check.
3. If a student withdraws from school voluntarily on the opening day or thereafter, advance tuition payments will be refunded less \$500.00. All other fees are nonrefundable.
4. The parent(s)/guardian(s) have signed a document acknowledging receipt of the ***Student-Parent Handbook*** and agree to be governed by these documents.
5. The parent(s)/guardian(s) agree to participate in and support all school activities, including fundraising events.
Parent(s)/Guardian(s) agree to make an annual fundraising contribution of \$250.00 per semester (\$500 annually).
