TERMS AND CONDITIONS:

- In order to participate in the program, your child must be currently enrolled in Frederica Academy and have a completed registration form in FACTS.
- A 10% discount will be applied only to the oldest sibling attending KiX when a family has multiple siblings in attendance.
- Parents are required to inform KiX (in addition to the school nurse) if their child develops allergies, asthma, or any other medical or contagious illness after initial medical forms are submitted. A confidential copy of the school's medical record for your child will be kept in KiX for all registered KiX students.
- If a child has food allergies, please send in an additional snack for your child to have at KiX.
- All FA rules, regulations, and procedures apply to the KiX Program, including, but not limited to, the Release of Liability and the Permission to Acquire Medical Treatment.
- KiX follows FA's 2026-2027 Lower School schedule. For 5th and 6th grade parents especially, please stay alert for any changes.
- Parents are responsible for providing the KiX Program Director with up-to-date contact numbers as well as any changes regarding those individuals authorized to pick up from KiX. Students will only be released to individuals listed on the approved pick-up list and are not permitted to be picked up by Middle or Upper School age siblings unless they are licensed drivers who are listed as an authorized individual. No students will be released as walkers per the Lower School Handbook. In the event of an emergency, please contact the KiX Program Director at (423) 782-7716.
- A one-time fee of \$40 will be charged for supplies that include age appropriate materials (crayons, markers, etc.) for PreK through 6th grade. This fee will be assessed in full regardless of the student start date in KiX.
- A late fee of \$50 will be assessed if your child remains after 6:00 p.m. Please plan for inclement weather and traffic.
