IMPORTANT INFORMATION ABOUT THE PROGRAM:

The duration of the Two-Way Bilingual Immersion Program is from Kindergarten through sixth (6th) grade. All subjects are taught in Spanish according to the schedule below. English reading is not introduced until 3rd grade.

| TK/Kindergarten - 90% instruction in Spanish and 10% in English. | 3rd grade - Reading instruction in English begins: 60% instruction in Spanish and 40% in English. |
| 1 st grade - 80% instruction in Spanish and 20% in English. | 4 th - 6 th gr. - 50% instruction in Spanish and 50% in English. |
| 2 nd grade - 70% instruction in Spanish and 30% in English. | |

- The program is based on a balance of the number of English and Spanish speaking students. Students who speak only English may enter the program in TK, Kindergarten, or 1st grade. Students entering after 1st grade must be reasonably fluent in both English and Spanish.
- Before entering the program, the parent/guardian and child are requested to visit a Two-Way Bilingual Immersion classroom and attend a Program Orientation at Ramona with the coordinator of the program.
- Parents/Guardians will attend the Two-Way Bilingual Immersion Academy Meetings.
- **Enrollment Process: Forms will be accepted beginning February 2, 2026.** Enrollment forms are available at, and must be submitted to the **Ramona Elementary School**, (310) 675-7189, located at 4617 W. 136th Street and date stamped. Parents/Guardians will be notified by the end of June if their child meets the criteria to be enrolled into the program. Forms submitted after June may be considered and added to a waiting list.
- **A permit application must be submitted if the student does not live in the Ramona attendance area. The student must maintain good attendance and behavior or the permit may be revoked, and the child may be returned to his/her home school. Transportation to Ramona School is the responsibility of the parent/guardian.**
