Dear Parents,

WELCOME to the Wilson Area School District!

Please read below for important information regarding kindergarten registration for the 2026-2027 school year.

Online Enrollment:

The Wilson Area School District is now accepting applications online for new student enrollment. Online applications are available in multiple languages. After completion of the online application, you will be contacted by the building secretary to finalize your student's enrollment.

To enroll online, please go to the district website at www.wilsonareasd.org, CLICK ON THE BOX THAT SAYS **ENROLL** on the top right hand corner. You will be able to access the following links on the website to complete your application:

If this is the first time you are enrolling a student/s, you will need to click the following link to create a username and password and begin the registration process:

If you currently have a student/s attending the Wilson Area School District and you need to enroll an additional student, you will need to use your existing Skyward Family Access login at the following link:

(once you are logged in, you will click the new student enrollment button on the left hand menu)

****When enrolling online you will be asked to give your child's birth date. At this point the system may show your child in PK (pre-kindergarten), however, when you scroll down the application, please check "Next School Year" for kindergarten enrollment.**

Children entering kindergarten must be five (5) years of age by September 1, 2026. You will be asked to provide a copy of the child's birth certificate, copy of the immunization record from the doctor, and **two proofs of residence from the following list, as required by law and regulations, to complete the registration.**

IMMUNIZATION REQUIREMENT: Immunization Record Must Show the Following:

1. Tetanus & Diphtheria - 4 doses (one after 4th birthday)
2. Polio - 4 doses (one after 4th birthday)
3. MMR - 2 doses (the first given after 12 months of age)
4. Hepatitis B - 3 doses (the last given after 6 months of age)
5. Varicella Vaccine - 2 doses (or proof of having had chicken pox)

EXAMPLES OF PROOF OF RESIDENCE (TWO OF THE FOLLOWING REQUIRED):

1. Utility bill
2. PA Department of Transportation identification or driver's license
3. PA Department of Transportation vehicle registration
4. Copy of state/federal program enrollment
5. Copy of paycheck stub with name and address of employee and employer
6. Residency Affidavit
