## **Notice of Designation of Private Space for Females Only**

This area is designated as a private space for females only under Texas Government Code Chapter 3002. Males may not use this private space, except as provided by law.

Please see a staff member if you need access to a single-occupancy restroom, locker room, or changing room.

## **Notice of Designation of Private Space for Males Only**

This area is designated as a private space for males only under Texas Government Code Chapter 3002. Females may not use this private space, except as provided by law.

Please see a staff member if you need access to a single-occupancy restroom, locker room, or changing room.

Thank you for your cooperation.

## **Notice of Designation of Non-Private Space**

This area is designated as a non-private space under Texas Government Code Chapter 3002. This space may be used for coaching, instruction, rehearsal, training, medical care, media coverage, or other purposes approved by the Superintendent.

Please be advised that activities in this space should not be considered private. School personnel may enter and observe this area as needed.

## **Notice of Designation of Temporary Change of Designation of Private Space for Athletic Locker Rooms**

This area is normally designated as a private space for one biological sex under Texas Government Code Chapter 3002.

This area is temporarily designated as a non-private space during the following times:

**15 minutes prior to game time**

**Halftime**

**15 minutes after the game ends**

During these non-private times, students should not change clothes or be in a state of undress because school personnel of the opposite sex may enter the area for coaching, instruction, rehearsal, training, medical care, or other purposes approved by the Superintendent.

## **Notice of Designation of Temporary Change of Designation of Private Space**

This area is normally designated as a private space for one biological sex under Texas Government Code Chapter 3002.

This area is temporarily designated as a non-private space during the following times:
