***To enroll in an AP course for the 2026-2027 school year, this document must be signed and returned to your counselor.***

John C. Kimball High School is committed to providing an environment in which all students have equal access to Advanced Placement (AP) classes. Students who enroll in AP courses are willing to meet the challenges of college level curriculum as directed by the College Board. Please visit [www.collegeboard.org](http://www.collegeboard.org) to review the AP program.

In order to ensure that our students are making an informed decision regarding enrollment in AP classes, John C. Kimball High School needs both the student and their parent/guardian(s) signature on the contract.

We will notify you before the end of this school year that you are enrolled in an AP course. You must attend a mandatory meeting with the teacher(s) of the respective AP class/es in which you are enrolled. This meeting will occur prior to the end of this school year. At this meeting, the teacher(s) will present the course expectations and explain the summer assignment requirements and expectations. **Students are not allowed to drop AP courses.**

Some considerations to keep in mind are:

1. The completion of summer work is essential in order to be appropriately prepared for the AP course/s. Summer assignments are due the first day of class. **Students not completing the summer assignment will not be allowed to drop the course.**
2. Due to the college level curriculum taught in each of these courses, counselor or administrative approval is required to enroll in more than three (3) AP courses.
3. AP students are highly encouraged to register for the AP Exams, which are administered in May 2027.

The staff and administrators are excited to provide an opportunity for students to take a college level academic course. We commend you for choosing this opportunity! The AP experience is rewarding and will help prepare you for your post-secondary education.
