- 1.01 Call to Order, Roll Call, Affirmation of Public Notice – The Board will convene in Room 207.

#### **2. Closed Session**

- 2.01 Motion and roll call vote to go into closed session pursuant to Wis. Stat. Section 19.85(1)(c) to consider employment, promotion, compensation or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility; Wis. Stat. Section 19.85(1)(f) to consider financial, medical, social or personal histories or disciplinary data of specific persons, preliminary consideration of specific personnel problems or the investigation of charges against specific persons except where par. (b) applies which, if discussed in public, would be likely to have a substantial adverse effect upon the reputation of any person referred to in such histories or data, or involved in such problems or in investigations and Wis. Stat. Section 19.85(1)(g) to confer with legal counsel for the governmental body who is

rendering oral or written advice concerning strategy to be adopted by the body with respect to litigation in which it is or is likely to become involved, specifically to discuss an employment investigation and continued employment of District personnel; to consider an appeal pursuant to Step 4 of District Procedure BDDI-R (1) and Board Procedure 13: Formal Appeal Process of a complaint from a community member; and to discuss two ongoing investigations into complaints against school board members.

### **3. Open Session**

- 3.01 Discussion regarding the Superintendent Search/Replacement Process.
- 3.02 Discussion and potential action regarding the policy and process to implement for the solicitation and review of superintendent search firms.
- 3.03 Discussion regarding a possible closed session discussion under Wisconsin Statute section 19.85(1)(e) to review negotiation parameters over the solicitation of, and contract parameters with, superintendent search firms will occur prior to any potential closed session. The requirement for the closed session to discuss negotiation parameters over the contract parameters with superintendent search firms is due to the fact that the district has not implemented a process for the solicitation or review of superintendent search firms, reached an agreement with any potential superintendent search firm(s), and the possible closed session will afford the Board the ability to establish negotiation parameters for the purchase of any specific superintendent search services.
- 3.04 Discussion regarding a possible closed session discussion under Wisconsin Statute section 19.85(1)(e) to review negotiation parameters over the terms and conditions of the Superintendent's resignation from District employment occurring on June 30, 2026 due to the Superintendent's notification to the Board that he has been offered employment at another school district and due to the fact that the possible closed session will afford the Board the ability to establish negotiation parameters for the terms and conditions of the Superintendent's resignation from District employment.

Discussion of staff planning regarding individual administrator assignments and duties; and c. Discussion and potential action regarding negotiation parameters for the purchase of any specific superintendent search services.

- 5.01 Discussion and potential action, if any and appropriate, regarding negotiation parameters for the purchase of the specific superintendent search services.
- 5.02 Discussion and potential action regarding the acceptance of the resignation of the Superintendent including the discussion and potential action regarding the terms and conditions of the Superintendent's resignation from the District.
