Director Vellanoweth thanked Commissioner Ewing and Commissioner Gooch for attending the announcements of the Classified School Employees of the Year. Director Vellanoweth recognized two employees of Ocean View School District, one current and one retired, who recently passed away. Theresa Rutledge was an Instructional Assistant – Special Education at Oak View since 2007. Nancy Sebring retired in 2009 and had been employed at Ocean View School District for 23 years.

Although the District Office was closed over the winter recess, Diana and Betzabeth were here at work keeping things moving. They were able to make job offers to two Computer Multimedia Technicians, a Network Systems Specialist, a Food Service Worker, and two School Office Clerks.

During the month of December, 55 candidates were invited to test, 45 candidates participated in oral exams, and seven candidates participated in final interviews. Thirteen job offers were extended and 29 on-boarding appointments were completed.
