Director Vellanoweth recommended that an eligible for the position of Universal Instructional Assistant be removed from eligibility list 2023-41 for reasons outlined in the letter that was provided to the Commissioners. Director Vellanoweth communicated with the candidate and advised that they were being removed from the eligibility list and is not eligible to reapply for positions with Ocean View School District in the future. The letter was also sent to the candidate and there has not been a request for an appeal.

Commissioner Gooch acknowledged that new processes have been implemented to make applicants aware that they are required to disclose anything that may show up on a background check. He asked Director Vellanoweth to refresh his memory how this is done. Director Vellanoweth answered that within the job application, there is a detailed section that explains what information needs to be disclosed about previous convictions. With this, there are still occasions where candidates are not forthcoming, are incomplete, or inaccurate in their disclosure on their application. To provide another opportunity for disclosure, after a job offer is made and the candidate comes in for their pre-employment paperwork, they are provided a form that allows them a second opportunity to disclose any convictions they may have omitted from their application.

Commissioner Gooch asked if the form could be modified to have the important information relating to what must be disclosed designated in red. Director Vellanoweth answered that the form could be modified. Commissioner Gooch asked if the Commissioners could see a sample of the form once it is modified. Director Vellanoweth answered yes. She also clarified that there are a variety of reasons why someone may be removed from an eligibility list, not just because of non-disclosure on an application.

Director Vellanoweth confirmed that the next meeting of the Personnel Commission would be January 18, 2024. She congratulated Commissioner Ewing and Commissioner Bidnick on being elected as Chair and Vice-Chair for the upcoming year. She thanked the Personnel Commissioners and the staff for all the work that has been accomplished over the last year.

She also thanked the Personnel Commissioners for their efforts in building and fostering a deeper relationship with the Superintendent, Board of Trustees, and administration at Ocean View School District.

The results from the FCMAT study have been received and their recommendations will be reviewed and prioritized. Although some recommendations are already in place, this will be seen as an opportunity to improve and monitor our progress.

This week the Board of Trustees approved the Personnel Commission's recommendation for salaries for the newly reactivated classifications of Audiovisual Technician and Information Technology Support Specialist, in addition to the salary range reallocation for the Database Analyst.

This past month 42 job offers were extended in a variety of classifications. Eleven individual one-off testing sessions were accommodated. As part of the district's Transition Team that Director Vellanoweth is a part of, she is meeting regularly with other directors and Cabinet to discuss the Spring View closure and consolidation. Director Vellanoweth has already begun reviewing the staffing for Spring View to see what it looks like as far as placement for the upcoming school year, potential vacancies, and strategizing where there might be alternate placements for current Spring View employees. Lastly, she wished everyone a safe and happy holiday season and hopes that everyone can take some time to relax and enjoy time with those that they love.

Michelle Eifert, Personnel Assistant, wished everyone a happy holiday. She also thanked Dale Jacobson for all his help over the years with many various technical issues, oftentimes at the very last minute. But most notably, long before the Personnel Commission meetings started being video recorded one year ago, every month before each meeting he set up an audio recording so that the minutes of the meeting could be easily transcribed for the meeting agendas. It has always been greatly appreciated. She wished him well in his retirement.

Background Information

Candidate Christopher Ruiz has been offered the position of Custodian. Pursuant to Merit Rule 7.2.1.3.A.3, an Advanced Step Placement Request for Mr. Ruiz (attached), is being brought to the Personnel Commission for approval.

Analysis

The advanced step request for Step 3 placement (\$23.930 per hour) on the appropriate salary range for the classification of Custodian (Salary Range 28, \$21.690 per hour to \$26.426 per hour) on the Classified Bargaining Unit Salary Schedule, comes to the Commission upon the request of Maintenance and Operations Supervisor, Joe Sejuit, the support of Interim Assistant Superintendent, Felix Avila, and the approval of the Director, Classified Personnel.

The rationale for the Personnel Commission to approve this request includes, but is not limited to: the candidate having more than five years of experience in the custodial field including Head Custodian experience, his previous employment as a Custodian with Ocean View School District, his being a long term substitute for Ocean View School District, his great work ethic, and the difficulty attracting qualified candidates for Custodial positions, some of which have been vacant for six months or more.

The Advance Step Placement Request Form provides further details of how the candidate exceeds the job-related experience and training required and makes the candidate especially qualified for the position.

7.2 APPLICATION OF SALARY SCHEDULES

7.2.1 Initial Placement

New employees shall be hired at the first step of the appropriate salary range unless advanced step placement is requested and approved according to the following procedure:

1. The appointing authority requesting advanced step placement shall complete the form entitled "ADVANCED STEP PLACEMENT REQUEST FORM" and attach any support materials. The form shall specify the outstanding factors by which an applicant may be granted advance step placement. Applicants will not be requested or prompted to provide previous salary information. If an applicant voluntarily and without prompting discloses salary history information, it may be considered in determining salary step placement.

2. The appointing authority sends the completed form and support materials to the Assistant Superintendent, Human Resources for approval.

3. The Assistant Superintendent, Human Resources, will either approve or reject the request.

A. APPROVAL

1. If approved, the Assistant Superintendent, Human Resources, will forward the request to the Director, Classified Personnel of the Personnel Commission.

2. Upon receipt of the approved request form, the Director, Classified Personnel will review the form ensuring completeness and shall attempt to verify the pertinent information contained therein.

3. The approved request will be placed upon the Commission agenda for approval.

4. Commission approved requests for advanced step placement shall be effective the date the employee officially assumes the duties of the position (effective date of appointment).

5. Upon approval by the Commission, the request is routed to Commission staff who will prepare the necessary payroll information.

6. A copy of the form is then placed in the employee's personnel file.

B. REJECTION

1. If rejected by the Assistant Superintendent, Human Resources, or by the Director, Classified Personnel, the form will be returned to the originator (with reasons indicated for the rejection).

2. Should the appointing authority still wish to pursue the advanced step placement, the form along with all support data and reasons for the resubmission will be forwarded to the Director, Classified Personnel who will place the item on the next Commission agenda for action. All support information will be made available to each Commissioner in the agenda packet. Action by the Commission will be final.

3. If approved by the Commission, the request will be routed as in numbers 5 and 6 above.

4. If rejected, the form will be returned to the originator with the reasons given.

5. A copy of the form will then be placed in the employee's personnel file.
