A pan of broccoli in hot holding cabinet had temperature of 121°F measured. Broccoli reheated to 172°F at time of inspection. Maintain hot time/temperature control for safety foods at a minimum critical temperature of 135°F.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.
