The reorganization meeting of the Board of Directors of the Conewago Valley School District was called to order in the District Office at 7:00 p.m. President Mr. Jeff Kindschuh called the meeting to order. Also present were Superintendent Dr. Sharon Perry, Assistant Superintendent Dr. Wesley Doll, Business Manager Mr. Scott Fraser, Director of Technology Mr. Nicolas Zepp and Solicitor Mr. Seth Byers.

Board Secretary Scott Fraser reported that the meeting was duly called and that due notice was given as required. (Sec. 402-School Code-BP005)

Mrs. Miller made a motion, seconded by Mr. Getz nominating Ms. Krug Temporary President. By voice vote, the motion was carried.

It was confirmed that all newly elected directors are qualified and eligible as required (Sec. 322 and 323).

Mr. Flickinger made a motion, seconded by Mrs. Sauter nominating Mr. Kindschuh for Board President.

Roll call vote: Mr. Meckley-aye; Mrs. Sauter-aye; Ms. Krug-aye; Mr. Campbell-aye; Mr. Flickinger-aye; Mrs. Swope-aye; Mrs. Miller-aye; Mr. Getz-aye and Mr. Kindschuh-aye. Motion was carried.

Mr. Kindschuh was elected President of the Board for a one-year term.

Mr. Meckley made a motion seconded by Mrs. Sauter nominating Mr. Flickinger for Vice-President. Mr. Getz made a motion, seconded by Mrs. Swope to nominate Ms. Krug for Vice-President.

Because there was more than one nominee for Board Vice President, the persons nominated were voted on in the order they were nominated. The first nominee to receive a majority of the votes will be elected Vice President.

Roll call vote for Board Vice President Nominee Mr. Flickinger: Mr. Meckley-aye; Mrs. Sauter-aye; Ms. Krug-nay; Mr. Campbell-aye; Mr. Flickinger-aye; Mrs. Swope-nay; Mrs. Miller-nay; Mr. Getz-nay and Mr. Kindschuh-aye. Motion was carried.

Mr. Flickinger was elected Vice-President of the Board for a one-year term.

Discussion to hold the regular public meetings and Committee of the Whole study session meetings of 2026, always to begin at 7:00 p.m. of the prevailing time; to set the Facilities Committee, Finance Committee, Athletics Committee, Board Policy Committee and Personnel Committee meeting to be scheduled as needed, always to begin 6:00 p.m. of the prevailing time. Discussion to continue with the Committee of the Whole and special committee format.

Ms. Krug made a motion, seconded by Mrs. Sauter nominating Mr. Fraser to serve as the Board's representative to the York/Adams Tax Bureau.

Roll call vote: Mr. Meckley-aye; Mrs. Sauter-aye; Ms. Krug-aye; Mr. Campbell-aye; Mr. Flickinger-aye; Mrs. Swope-aye; Mrs. Miller-aye; Mr. Getz-aye and Mr. Kindschuh-aye. Motion was carried.

Mr. Fraser was elected to serve as the Board's representative to the York/Adams Tax Bureau.

By common consent and action, Mr. Kindschuh adjourned the meeting at 7:12 p.m. for the Committee of the Whole study session of the Conewago Valley School District.
