
MINUTES OF THE MILLVILLE SCHOOL DISTRICT REORGANIZATIONAL BOARD MEETING

The Millville Area School Board held their reorganizational meeting on Wednesday, December 3, 2025 in the Millville Jr./Sr. High School Library beginning 7:13 pm. Prior to the meeting, the Board held an Executive Session for a number of personnel and legal matters.
