MINUTES OF THE MILLVILLE SCHOOL DISTRICT SPECIAL BOARD MEETING

The Millville Area School Board held a special meeting on Monday, December 8, 2025 in the Millville Jr./Sr. High School Library beginning 7:03 pm.

**1. ROLL CALL**
