### PROOF OF RESIDENCY

Students MUST PHYSICALLY RESIDE with parent/guardian in the address given to the district at the time of registration. Parent/guardian will need one or more of the following also:

#### Proof of Residency: HOME OWNERSHIP

If the parent/guardian is an Eden Central School District **Home Owner** you must provide **ALL THREE** of the following for registration:

1. Notarized Resident Affidavit – on back under HOME OWNERSHIP (and)
2. Recent Utility bill with an Eden Central School District address. (and)
3. Second recent Utility Bill with an Eden Central School District address.

#### Proof of Residency: RENTER

If the parent/guardian is an Eden Central School District **Renter** you must provide **ALL THREE** of the following for registration:

1. Notarized Landlord Affidavit – on back under RENTER (and)
2. Recent Utility bill with an Eden Central School District address. *Additional Residency Documentation options at the bottom of this page.* (and)
3. Landlord Lease.

#### Proof of Residency: LIVING WITH FAMILY MEMBERS OR FRIENDS

If the parent/guardian is an Eden Central School District **Living with Family members or Friends** you must provide **ALL THREE** of the following for registration:

1. Notarized Living with Family members or Friends Affidavit – on back under LIVING WITH FAMILY MEMBERS OR FRIENDS (and)
2. Recent Utility bill with an Eden Central School District address. *Additional Residency Documentation options at the bottom of this page* (and)
3. Closing Statement or Deed verifying the residency of the family member or friend.

#### ***Residency Documentation Options***

(d) The district shall consider other forms of documentation produced by the child, the child's parent(s) or person(s) in parental relation, including but not limited to the following:

- (1) pay stub;
- (2) income tax form;
- (3) utility or other bills;
- (4) membership documents (e.g., library cards) based upon residency;
- (5) voter registration document(s);
- (6) official driver's license, learner's permit or non-driver identification;
- (7) state or other government issued identification;
- (8) documents issued by federal, state or local agencies (e.g., local social service agency, federal Office of Refugee Resettlement); or
- (9) evidence of custody of the child, including but not limited to judicial custody orders or guardianship papers.

(b) The district may require that the parent(s) or person(s) in parental relation submit documentation and/or information establishing physical presence of the parent(s) or person(s) in parental relation and the child in the school district.
