

TEAM ENTRY FORM AND RELEASE AND WAIVER OF LIABILITY AGREEMENT

THIS TEAM ENTRY FORM AND RELEASE AND WAIVER OF LIABILITY AGREEMENT (the "Agreement") is executed as of the date of signatures below, by the undersigned participants (each a "Participant" and together, the "Participants") in favor of Holy Cross College, Inc. dba Holy Cross School ("Owner"), in connection with Holy Cross School's Family Day Crawfish Cook-Off (the "Event") to be conducted on Saturday, March 14, 2026 on Owner's property located at 5500 Parish Avenue, New Orleans, LA 70122 (the "Property").

- Acknowledgment and Assumption of Risk.** Each Participant acknowledges and understands that entering onto the Property and participating in the Event involves certain risks, including but not limited to the risk of personal injury, property damage, or death. These risks may result from the condition of the Property, the activities conducted during the Event, the actions or inactions of others, or other causes. Each Participant hereby voluntarily assumes all risks, known and unknown, associated with entering onto the Property and participating in the Event, even if arising from the negligence of the Released Parties (as defined below) or others, and assumes full responsibility for each such Participant's participation in the Event.
- Rules and Regulations; Compliance with Laws.** Participants will comply with all rules, regulations, and instructions governing the use of the Property and participation in the Event, including the Crawfish Cook-Off Rules for the Event which have been provided to Participants and made available at www.hcnola.org. Each Participant agrees to comply with all applicable federal, state, and local laws, regulations, and ordinances while on the Property and participating in the Event.
- Release from Liability.** Each Participant, on behalf of herself/himself and her/his heirs, executors, administrators, personal representatives, successors, and assigns, hereby releases, waives and discharges Owner, and its affiliates, directors, officers, employees, agents, volunteers, successors, and assigns (collectively, the "Released Parties") from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by her/him, or to any property belonging to her/him, while on the Property or participating in the Event, regardless of whether such loss, damage, or injury is caused by the negligence of the Released Parties or otherwise.
- Indemnification.** Each Participant hereby agrees to defend, indemnify, and hold harmless the Released Parties from and against any and all claims, liabilities, damages, costs, and expenses, including attorneys' fees, arising from or related to each such Participant's entry onto the Property or participation in the Event, including but not limited to claims arising from the negligence of Participant or Participant's failure to comply with the terms of this Agreement.
- Responsibility for Personal Property.** Each Participant acknowledges and agrees that the Released Parties shall not be responsible for any loss or damage to Participant's personal property that occurs on the Property or in connection with the Event.
- No Representations by Released Parties.** Each Participant acknowledges that the Released Parties have made no representations or warranties, express or implied, concerning the safety of the Property or the Event. Each Participant understands and agrees that the Released Parties shall have no obligation to provide any warnings or to take any other precautionary measures in connection with the Property or the Event.

EACH UNDERSIGNED PARTICIPANT IN EXECUTING THIS AGREEMENT HEREBY ACKNOWLEDGES THAT SHE/HE HAS FULLY READ THE ABOVE PROVISIONS OF THIS AGREEMENT AND UNDERSTANDS THAT THIS AGREEMENT INCLUDES A RELEASE OF LIABILITY AND A WAIVER OF HER/HIS RIGHT TO OBTAIN COMPENSATION FROM THE RELEASED PARTIES FOR ANY INJURIES OR DAMAGES THAT SHE/HE MAY SUSTAIN ON THE PROPERTY DURING THE EVENT.
