## 2025-26 Quality, Currency, Availability of Textbooks and Other Instructional Materials

Alview-Dairyland Union School District held a public hearing on September 9, 2025 and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. Core subject textbooks and instructional materials are provided for each student, including English learners. Standards-aligned texts and materials are reserved both for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the state are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. The table displays information about the quality, currency, and availability of the standards-aligned textbooks and other instructional materials used at the school. In addition to textbooks, all students have access to two school-issued computers; one for home and one for school use. If needed, a hotspot is also provided for those students who connectivity for independent study access.

## School Facility Conditions and Planned Improvements

Dairyland Elementary School was originally constructed in 1915 and is comprised of nine classrooms, multipurpose room, STEM lab, music room, intervention learning center, library, staff lounge, playground and an outdoor solar shade structure. Facility and inspection information is current as of December 2025.

### Cleaning Process:

The Director of Operations works daily with the custodial staff to maintain the cleanliness and safety of the school. The district governing board has adopted cleaning standards for all schools in the district. Due to COVID-19 protocols, new procedures were implemented in the fall of 2020 and have remained in place to disinfect classrooms, restrooms and play equipment on a regular basis.

### Maintenance and Repair:

District maintenance staff ensures that the repairs necessary to keep the school in good repair and work orders are completed in a timely manner. A work order process is used to ensure efficient service and highest priority are given to emergency repairs. At the time of publication 100% of restrooms were in working condition.

## 2025-26 School Safety Plan

The safety of students and staff is a primary concern of Dairyland Elementary School. The school complies with all laws, rules, and regulations pertaining to hazardous materials, state earthquake standards, pandemic and emergency response protocols, etc. The School Safety Plan was developed and updated in the spring of 2025 by the School Site Council. Further input was gleaned from staff, law enforcement and the school community in August of 2025. The plan was subsequently approved by the School Site Council and Governing Board in December of 2025. In addition to the elements listed above, the safety plan also includes the school's Disaster Preparedness Plan, the Instructional Continuity Plan, Student Threat Assessment Information, and a Workplace Violence Prevention Plan. In 2025-26 the plan was updated to include information for sudden cardiac arrest, staff code of conduct, and the SAFE Act.

With regard to student supervision and safety on campus, students are supervised before and after school, during lunch, and break periods. During the school day, gates are locked and visitors are limited to entry through the school office. In the fall of 2022, access controls were installed on the campus to ensure all doors remain locked throughout the school day and visitors to the office are screened before entering. The school provides two-way radios to enable those who are supervising students to maintain communication. There is a designated area for student drop-off and pick-up. Students coming and going during the school day must be signed in and out. Security cameras are placed around the perimeter of the school and cafeteria for student and facility safety.

## Professional Development

The focus of our staff development is Math, Science, ELA, STEM, and Explicit Direct Instruction. The methods for delivery of the staff development have included Monday staff meetings, back-to-school trainings, and buy-back days. Teachers are supported with ongoing observations, coaching, curriculum resources/planning and student data analysis. SEL training in recent years has focused on recognizing signs of student anxiety, depression and trauma as well as strategies and local resources for support. At the beginning of the 2022-23 school year, every teacher in the District received 1:1 coaching on Explicit Direct Instruction techniques to maximize student engagement. The focus for 2023-24 professional development was
