Tuition Insurance Plan	\$375	required per child

WWS Tuition Management 2026-2027 School Year

Tuition Management Policy

It is an obligation to pay the tuition and fees for the full academic year and this obligation is unconditional. On or before May 1, 2026, with written notice of cancellation, the family will forfeit the tuition deposit with no further tuition and fee obligations. By July 1, 2026, with written notice of cancellation, the family will forfeit the tuition deposit and two months of tuition payments, with no further tuition and fee obligations. After July 1, 2026, no portion of tuition or fees paid or outstanding will be refunded in the event of absence, withdrawal, or dismissal, except for students who are (a) provisionally accepted or (b) partially insured under the Tuition Insurance Plan. The family is financially responsible for the student(s) and legally obligated to pay the full tuition amount (including fees).

Payment Plans

Parents have three (3) options for how and when to complete their tuition and fees obligations.

One Payment Plan	The full balance of tuition and fees is due on May 15, 2026.
Two Payment Plan	The balance of tuition and fees is divided into two equal installments. First Installment Due: May 15, 20256 Second Installment Due: November 15, 2026
Twelve Payment Plan	The balance of tuition and fees is divided into twelve (12) equal installments. The first installment is due on May 15, 2026. Payments will continue to be due monthly on the 15th day of each month, up to and including April 15, 2027.

Deposit(s)

For new students, deposits are due on the due date stated on the acceptance letter. If you are applying for Tuition Assistance, you are required to pay a deposit of \$1,500. Deposits are non-refundable and non-transferable.

Tuition Insurance Plan (TIP)

If the child is withdrawn from school after the contract is executed, parents are eligible for a 50% liability release of the tuition related to unattended school days. The Tuition Insurance Plan must be paid in full. TIP is non-refundable and non-transferable.

Tuition Assistance (TA)

TA is available for ALL new and re-enrolling Nursery, Kindergarten and Grades 1-8 families, based on financial need. All interested families must complete the application process in its entirety via <https://online.factsmgt.com/signin/3FV07> by the posted deadline.
