2025-26 School Description and Mission Statement

The Buckeye Union Mandarin Immersion Charter School began in August 2018 with 42 students in Kindergarten and First Grade. The program and school continue to grow as we open more grade levels and more students enrolled. Students are taught by bilingual teachers with multiple subject credentials and supplemental authorization in Mandarin for their Mandarin instructional time, as well as a credentialed multiple subject teacher for the English portion of their day.

Students in Kindergarten and 1st grade receive instruction in Mandarin for 80% of the school day for Mandarin reading and writing, mathematics, science, and social studies. The other 20% of their instructional day is in English for English Language Arts and Mathematics vocabulary. As the grade levels increase, the instructional time split will change to 70/30 in 2nd grade,

60/40 in 3rd grade, and 50/50 in 4th and 5th grade. During the school week, students participate in other pull-out programs including P.E., library, and computer lab, which are taught in English.

This mission of the school is to provide an immersion program where all students reach Intermediate-High (Level 6) ACTFL Benchmark Level in reading, writing, listening, and speaking in Mandarin by the end of 5th grade as well as meeting or exceeding grade level standards in all curriculum areas in English. This is combined with the learning associated with Mandarin vocabulary and characters in core content areas.

School Facility Conditions and Planned Improvements

The Buckeye Union Mandarin Immersion Charter School is housed on the Oak Meadow Elementary School Campus. The Buckeye Union School District is proud of the facilities that are provided for students and families. Each year parent surveys indicate that they are pleased with the condition of the schools.

Oak Meadow Elementary School was originally constructed in July 2003 and is comprised of 32 classrooms, one multipurpose room, one administration building, one library, one staff lounge, one computer lab, and two playgrounds. In 2022, 86" Newline interactive displays were added in the classrooms. In 2024, the energy management system was upgraded to a Pelican wireless energy management system. Also in 2024, a Verkada perimeter security camera system was installed.

Cleaning Process:

The principal works daily with the custodial staff to ensure that the school is cleaned and maintained to provide for a clean and safe learning environment.

Maintenance and Repair:

District maintenance staff ensures that the maintenance and repairs necessary to keep the school in good repair are completed in a timely manner.
