



## 2026-2027 ONLINE ENROLLMENT PACKET INFORMATION

Tuition for the 2026-2027 school year is \$17,495. Additionally, families are responsible for a \$625 non-refundable registration fee, per student, paid at the time of enrollment/re-enrollment. Families who do not complete the enrollment process, including the payment of the enrollment fee, by the February 2, 2026 deadline will be charged a \$100 late fee. Additionally, the space will not be held and may cause a student to be moved to the waitlist.

Beginning with the submission of the Online Enrollment Packet, Parent understands they are entering into a legally binding agreement with Bishop Verot Catholic High School; that the terms and conditions of this agreement are set forth below; and that this agreement extends until the high school graduation of the Students from Bishop Verot or the termination of this agreement through the successful completion of the Withdrawal Process.

### Family Portal Account

**See the balance due:** Notice of the final balance due on tuition will be sent after any financial aid, state scholarships and FACTS Tuition payment plans have been completed, if applicable. Tuition can be paid in full or installments. All payments begin in July 2026 for the 2026-2027 school year. All scholarship awards and assistance will be applied to the tuition balance prior to the start of payments.

#### Choose a payment option:

**PAYMENT IN FULL:** Families who wish to pay the tuition in full, payment will be deducted from the account of your choice July 5<sup>th</sup> or July 20<sup>th</sup>, 2026. Credit Cards are accepted and subject to a 3.05% convenience fee. School accepts Visa, MasterCard, Discover, and American Express. A **\$20 enrollment fee is assessed for "1 payment in full."** This fee will be automatically processed within 14 days of the agreement being finalized and posted to the FACTS system.

**INSTALLMENTS:** 2, 4, 10, 11 or **\*12-month** payment plans are available. All plans begin July 5<sup>th</sup> or July 20<sup>th</sup>. A **\$20 enrollment fee is assessed for 2 payments plan.** A **\$46 enrollment fee is assessed for any installment plan of 3 or more payments.** This fee will be automatically processed within 14 days of the agreement being finalized and posted to the FACTS system. If the tuition is to be paid for, or shared with another party, a separate agreement is required for each party.

**\*Please note – when choosing a 12-month plan, tuition is not paid in full until the final payment posts in June 2026, after the end of the school year. Graduating seniors and students who may transfer will not receive final, official transcripts until the final payment is received.**

### FINANCIAL OBLIGATIONS POLICY

Accounts must be current for a student to attend classes (which includes starting classes at the start of the new year), participate in extra-curricular activities, take exams (including semester and final exams), receive schedules and report cards, participate in Graduation, and have records/transcripts released. Once an account becomes 30 days delinquent, the student is subject to dismissal from Bishop Verot.

## **Withdrawal/Dismissal**

Students who withdraw or are dismissed from Bishop Verot during the school year will be required to pay a tuition penalty for early withdraw, in accordance with the Student Handbook. Transcripts will not be released until all financial obligations are met, all school-issued items are returned, and the Student Withdrawal Form is signed by a parent.

## **NEED BASED TUITION ASSISTANCE, STATE OF FLORIDA SCHOLARSHIPS, AND CATHOLIC ALLOWANCE INFORMATION AND DEADLINES**

**ALL financial assistance is granted on a year by year basis, an application must be filed each year.**

### **Step Up for Students Tax Credit Scholarships**

The application for the 2026-2027 Tax Credit Scholarship will open on February 1, 2026. Please plan to complete this application process as soon as it opens to ensure your receipt of these funds. Once awarded, families must approve the quarterly disbursements to the school. If the disbursements are not approved timely, families will be responsible for the total cost of tuition.

### **BVHS Financial Assistance**

The FACTS Grant & Aid application is now open and must be completed and submitted, along with all required supporting documentation, by the **March 15, 2026 deadline** to be considered for any assistance. Determination and notification of need-based tuition assistance will be made in April 2026. Applications submitted after March 15, 2026 will be placed on a waiting list and will not be reviewed until after all timely filed applications have been reviewed. Please be advised financial aid funding is limited and applications not filed by the deadline may result in financial assistance being denied or may result in a reduced award. As financial assistance is granted on a year-by-year basis you must file a new application each year. **Bishop Verot cannot award any need-based assistance if any application is not timely and properly filed with both FACTS Grant & Aid and Step up for Students.**

### **Catholic Allowance**

Practicing Catholic families with a genuine need may now apply for the Catholic Allowance. To be eligible for the \$1000 Catholic Allowance, families must have their parish complete and return the Parish Enrollment Form (available on the website), verifying their parish status, prior to the May 4, 2026 deadline.

\*The Catholic Allowance is a tuition discount and is not subsidized by your parish.
