SCHOOL AND COMMUNITY PROFILE

Carl H. Sundahl Elementary School has served students residing on the northwest side of the American River in Folsom since September 1987. We operate on a traditional year calendar and serve students from TK to Fifth Grade. Our student enrollment is approximately 415 students; 17 percent of our students qualify for Free or Reduced Meals, six percent are English Learners, and three percent are Homeless. The surrounding neighborhood is populated with families who are eager to participate in the education of their children.

Carl H. Sundahl Elementary was completed and remodeled in 2018. The updated campus includes beautiful new classrooms, restrooms, playgrounds, and a school library. Our campus currently houses 21 classrooms, a Learning Center and a Student Care Center.

Currently, we have 17 General Education classes, one multiage Montessori classroom, and two Special Day classrooms. Our multipurpose room/cafeteria complex includes a stage/music room as well as a serving kitchen and an indoor basketball court. All classrooms are equipped with Internet access for curriculum and research support. Chromebooks are available on campus for student use in classrooms and for home checkout.

At Carl H. Sundahl Elementary, our primary goal is to prepare our students to become responsible citizens and productive, caring members of society. Our strong educational programs work to support each student to master essential standards. Opportunities for differentiated instruction are available for all students, including those identified for Gifted and Talented Education (GATE). Intervention programs include grade-level Multi-Tiered System of Support (MTSS) times, classroom-based

Response to Instruction (RtI) interventions, and small group reteaching. A wide variety of curriculum and enrichment activities are offered by staff and parent volunteers, including Parent Teacher Association (PTA) Movie Night, Cool2BeKind Week, Ruby Bridges Walk the School Day, Merrily We Walk to School, Starstruck Showcase Dance Performance, Dolphin Art, Author's Day, District Track Meet, and the Dolphin Dash jog-a-thon.

We provide an academically challenging curriculum in a caring and positive school environment. Our highly skilled staff is comprised of veteran teachers and National Board-Certified instructors. We have a strong schoolwide Positive Behavioral Interventions and Supports (PBIS) program utilizing The Dolphin 5 (Be Respectful, Be Responsible, Be Safe, Be Friendly, Be Productive) standards. We recognize and celebrate student progress and achievements. We have an active Student Council that leads spirit activities and community service on campus. Carl H. Sundahl Elementary has a strong and supportive parent community. Parents volunteer in classrooms and on field trips. Our Parent Teacher Association (PTA) plans activities and events that serve as a positive connection between home and school and provide financial support for key programs.

We use Parent Square, the school marquee, the school web page, and weekly newsletters to help keep the community informed and engaged.

All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the State Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. School Facility Conditions and Planned Improvements

Carl H. Sundahl Elementary has 21 classrooms, a multipurpose room, and an administration building. The main campus was built in 1988 as all portables and received a modernization with permanent buildings in 2017. All classrooms are equipped with a document camera and a Promethean Board. We also have a large playing field, play structure, and blacktop for recess and Physical Education (P.E) classes. Carl H. Sundahl Elementary is in the process of getting new roofs campus wide.

The LEA governing board has adopted cleaning standards for all schools in the LEA. The principal works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

The LEA participates in the State School Deferred Maintenance Program, which provides state matching funds on a dollar-for-dollar basis, to assist LEAs with expenditures for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems. For

Each accident was minor and addressed immediately. Safety plans are reviewed each fall; maintained and followed throughout the school year. Emergency plans have been developed in case a threatening situation should arise.

Our Safety Committee meets regularly to address concerns and to update and improve our emergency procedures and response time. We work closely with the Folsom Police and Fire Departments. Evacuation routes are in place and an emergency folder with supplies and class lists is kept up to date in every classroom. Safety drills are held monthly with students. We maintain a closed campus. Once school starts, gates are locked, and all students and visitors enter the school through the Office.

Professional Development

Folsom Cordova Unified School District provided staff with three professional development days this school year. Each employee is encouraged to grow professionally through self-evaluation and reflection; by attending college and university classes as well as statewide and local workshops; reading professional literature, and networking. District-sponsored in-service training is provided through Professional Learning Communities (PLC) training, lead teachers, Teachers on Special Assignment (TOSA), and site-level academic, reading, math, science, and technology coaches. Professional development was also offered on the Science of Reading (SOR), English language development, Positive Behavior and Intervention Supports (PBIS), and on other instructional practices. FCUSD district staff work collaboratively to provide an induction program for qualified new teachers and ongoing professional development workshop options.

At the school site, professional development is focused on ensuring students master essential standards through collaborative work in Professional Learning Communities.
