Board Meeting Highlights

The Paulding County Board of Education held a Board Retreat at the Dianne Wright Innovation Center. During the retreat, Steve Barker, Georgia School Boards Association (GSBA), facilitated a whole-board training session for members of the Paulding County Board of Education.

Anna Durham, Chief Financial Officer, presented the Quarterly Financial Update for September 2025. The presentation provided an overview of the General Fund, including trends in revenue and expenditures, the current fund balance, grants, capital projects, and debt service funds. The complete financial report is available on the district's website.

Mr. Barnette shared an update on Crossroads Elementary School construction. The school is on schedule to open August 2026.
