The Pleasant Valley School District Board of Education is pleased to offer the Property School Tax Rebate to its qualified residents. Enclosed under this cover is the Pleasant Valley School District Property School Tax Rebate Form for 2025. If you need assistance, business office staff can assist you in the completion of your form. The following dates have been set aside:

Tuesday, February 24, 2026	10:00 a.m. to 12:00 noon and 1:00 p.m. to 2:00 p.m.
Thursday, March 19, 2026	10:00 a.m. to 12:00 noon and 1:00 p.m. to 2:00 p.m.
Wednesday, April 29, 2026	10:00 a.m. to 12:00 noon and 1:00 p.m. to 2:00 p.m.

If you would like assistance, please call (570) 402-1000 to schedule an appointment to have your school property tax rebate form completed. You will need to bring with you the following documentation in order to complete the process:

- Proof of all household income for the 2025 year (including social security and retirement, pensions, interest, dividends, rental income, IRA distributions, wages, unemployment compensation, etc.)
- Your **paid in** 2025 school property tax bill
- Proof of Age (Valid forms of ID: Birth Certificate, PA driver's license, or PA identification card.)
- Copy of your completed 2025 PA-1000 State Property Tax Rebate Form

Copies of this information will be made here at the district so you can return home with your original documents.

In an effort to move paperless, we are encouraging tax payers to scan and email their tax rebate forms and all required documentation to the PVSD Business Office at eilber.donna@pvbears.org.

PLEASE NOTE: We ask that you enter the driveway that is directly across from the GULF Gas Station on route 115. Please drive forward and park in the lot immediately in front of the district office building. Enter the door under the Blue Roof.

All Pleasant Valley School District Property Tax Rebates must be filed with the Business Office by **December 31, 2026.**

Excessive claims made with fraudulent intent will subject the claimant to a penalty of 25% of the entire amount claimed. The claimant shall be guilty of a misdemeanor punishable by a fine up to \$1,000 and/or imprisonment up to 1 year upon conviction.

INSTRUCTIONS FOR 2025 PROPERTY TAX SCHOOL REBATE

How to complete the PVSD Property School Tax Rebate Application:

1. **COMPLETE PART A:** Fill out as much information as possible. Be sure to include your spouses' information, if necessary. Please provide proof of birth date. You can use one of the following as proof of age: your birth certificate, PA driver's license, or PA identification card.
2. **COMPLETE PART B:** Check Yes or No in the following boxes
3. **COMPLETE PART C:** Fill out as much information as possible. Only the paid school taxes on the primary residence where you live are eligible for rebate. Include a copy of the paid property tax receipt for the school taxes. A cancelled check is not acceptable.
4. **COMPETE PART D:** Sign and date

FAQ about the PVSD Property Tax Rebate:

1. **When can we file for our Rebate?** After February 1, 2026, and before December 31, 2026. If your application is received after December 31, 2026 we *cannot* process your application.
2. **Where do we bring the completed application?** You can mail or bring your form with all additional paperwork to the Pleasant Valley District Business Office at 2233 Route 115, Suite 100, Brodheadsville, PA 18322. Alternately, you can scan and email your tax rebate forms and all required documentation to the PVSD Business Office at eilber.donna@pvbears.org.
3. **What additional paper is needed with my application?** Please make sure you include the additional paper work listed below with your application:
 - Completed and signed copy of your PA-1000 Pennsylvania Property Tax /Rent Rebate form.
 - Copy of your paid in 2025 school tax receipt.
 - Copy of the documents supporting each income item shown on the state rebate form.
 - Proof of the eligibility. You can use one of the following as proof of age: your birth certificate, PA driver's license, or PA identification card.
4. **How much of a rebate can I be eligible for?** The Pleasant Valley School District offers a rebate on taxes paid after the maximum rebate from the **Pennsylvania Property Tax /Rent Rebate**.

Schedule of Rebate for taxes in excess of **\$1000**

\$0 - \$ 8,270	up to \$1,00.00
\$8,271 - \$15,510	up to \$770.00
\$15,511 - \$18,610	up to \$460.00
\$18,611 - \$46,520	up to \$380.00
\$46,521 or over	Not eligible for rebate

MAXIMUM REBATE cannot exceed \$1,000 on primary homestead only
