School Mission, 2025–26

The mission of Jefferson School is to develop the intellectual, artistic, social, physical, and emotional capacities of each child through differentiated instruction so as to enable all students to succeed academically, develop personally, achieve their goals, and move forward on a path toward college and career. We endeavor to make learning meaningful and joyful and, in doing so, foster in students a love of learning that will last a lifetime. We strive to provide this education in a safe, nurturing environment where the dignity and uniqueness of every child is recognized and respected. We also strive to engage all stakeholders, especially parents, in this shared educational endeavor.

2025-26 School Description and Mission Statement

School Description, 2025–26

Jefferson Elementary, the only school in the Jefferson School District, is located in Paicines, California near Pinnacles National Park. There are no businesses or services in this small, rural, and somewhat remote district, with the nearest city, Hollister, located approximately 35 miles away. The school consists of two buildings. One building houses a large K–8 classroom and office space, while the second building serves as a multipurpose room and has the potential to function as a community center after school hours.

At the beginning of the 2025–26 school year, six students in grades K–8 were enrolled at Jefferson Elementary. Approximately 67 percent of students were Hispanic, 50 percent were English Learners, and 0 percent received Special Education services. The district employs one full-time credentialed teacher who also serves as the principal and superintendent, supported by a full-time instructional aide. Jefferson Elementary’s small enrollment allows for highly individualized instruction and close monitoring of each student’s academic, social, and emotional development.

Educational Program, 2025–26

Although Jefferson Elementary is a small school, the instructional program is rigorous, engaging, and focused on student growth and academic achievement. California State Standards are taught in all subject areas, and multiple forms of data are used to set goals, guide instruction, monitor student progress, and evaluate program effectiveness. Assessments include ongoing formative assessments, STAR 360, and annual assessments such as ELPAC and CAASPP, as well as daily checks for understanding embedded within instruction.

Based on assessment data, instruction is highly differentiated to meet the needs of each student through a combination of whole-group, small-group, and one-on-one instruction provided by the teacher/principal. Core and supplemental instructional programs include Envision Math, Houghton Mifflin ELA, Social Studies Weekly, and Discovery Education Science. Each student has access to a laptop, and technology is integrated into teaching and learning on a daily basis. Students also receive a broad educational experience through science and social studies instruction, hands-on experiments, field trips, STEAM activities, art projects, and musical performances. Jefferson Elementary provides a safe, enriching, and supportive learning environment for all students.

School Facility Conditions and Planned Improvements

The school facility is inspected on a routine and ongoing basis by school staff and independent inspectors. The teacher/principal conducts informal daily inspections and is able to promptly identify and address potential safety concerns. Keenan & Associates conducts an annual inspection of the school facilities and grounds and provides a written report of findings. In addition, the teacher/principal conducts an annual inspection using the State Facility Inspection Tool (FIT), which provides standardized criteria for evaluating the condition of school facilities and assigning ratings of good, fair, or poor.

The most recent FIT inspection was conducted in November 2025 by the teacher/principal in collaboration with a Board member who supports facilities oversight. The inspection resulted in ratings ranging from fair to good for individual systems and an overall rating of good, indicating that school facilities are maintained in good repair with only isolated, non-critical deficiencies that are being addressed. Planned facility improvements under consideration by the School Board include potential generator installation, repairs to the blacktop, and fencing improvements.

2025-26 Opportunities for Parental Involvement

Jefferson School District is governed by a five-member Board of Trustees comprised of community members who serve by appointment to fill vacancies. The Board holds monthly public meetings during which parents and community members are encouraged to provide input on school and district matters. A calendar of Board meetings is shared with families, and meeting agendas are posted in advance to promote transparency and community participation. The teacher/principal maintains frequent communication with families through both formal and informal meetings to share student progress and gather feedback. These conversations play an important role in informing school planning and the development of the Local Control and Accountability Plan (LCAP).

Jefferson Elementary actively seeks to involve families and community members in school life. Announcements related to school events and opportunities for involvement are posted at the school, sent home to families, and shared online. With improved internet bandwidth and access to technology, the school continues to expand communication through platforms such as ClassDojo and Google Classroom. Parents participate in biannual parent-teacher goal-setting conferences and are invited to attend and support a variety of school and community events, including performances, field trips, STEAM activities, spelling bees, science fairs, and other enrichment opportunities.

2025-26 School Safety Plan

The Comprehensive School Safety Plan (CSSP) was reviewed and updated by the principal in January 2025 and approved by the Board. No major revisions were required. The Teacher/Principal developed and maintains the plan in collaboration with public health partners and other local school administrators. Emergency preparedness procedures were reviewed, including the inventory and stocking of emergency backpacks, with the addition of a donated emergency backpack during the 2025–26 school year. The school’s Hazardous Materials binder is compliant with state guidelines, and an approved safety inspection tool is used to conduct regular inspections of school facilities and grounds. The most recent inspection rated the facilities as “Good.”

The principal maintains a schedule, in accordance with state law, for conducting required fire, earthquake, and lockdown drills. All staff members are trained in mandated child abuse reporting and sexual harassment laws and prevention. In addition, 100 percent of staff completed First Aid training in September 2025. Jefferson Elementary is in compliance with applicable laws, rules, and regulations related to school safety.

Professional Development

The primary focus areas for professional development at Jefferson Elementary are determined by student achievement data, Local Control and Accountability Plan (LCAP) goals, and the identified needs of instructional staff. Professional development is designed to support instructional quality, student learning, and compliance with state and federal requirements in a small, rural school setting.

Jefferson Elementary staff includes the Teacher/Principal and a full-time Instructional Aide. The Teacher/Principal participates in ongoing professional development through the San Benito County Office of Education, including monthly Professional Learning Network and Superintendent meetings, as well as online trainings and webinars related to instructional practices, state assessment requirements, certification, and school safety. The Instructional Aide receives training and support through the Teacher/Principal, the San Benito County Office of Education, and contracted providers. During the 2025–26 school year, 100 percent of staff completed American Red Cross First Aid training.
