Principal's Message

Fryberger Elementary is committed to cultivating environmentally responsible citizens who think critically, collaborate effectively, and engage deeply in their learning. Our instructional program integrates environmental literacy across the curriculum, supporting California's adopted Environmental Literacy standards and preparing students to contribute thoughtfully to their community and the world around them. This focus helps students make meaning from authentic, real-world issues and fosters a strong sense of stewardship for the natural world.

Students experience a rigorous academic program with a focus on grade-level standards and supported by project-based

learning, STEM exploration, and one-to-one technology (iPads in TK and Chromebooks for grades 1–5). All students in TK–5 take home their devices to extend learning beyond the school day and strengthen technology fluency. Intervention and enrichment opportunities, including WIN (Whatever I Need) Tier 2 supports, GATE differentiation, and extracurricular programs and after school clubs, ensure that students are challenged and supported at their individual levels. Physical education, music, and art provide additional avenues for creativity, expression, and whole-child development and are taught by teachers credentialed in their area of expertise. Fryberger also places a strong emphasis on social-emotional learning so students feel connected, confident, and cared for at school. Each week begins with a schoolwide Monday Morning Meeting to build community and belonging, while teachers incorporate daily SEL check-ins and instruction into classroom routines. Students are recognized monthly with Growth Mindset awards that celebrate effort, perseverance, and the belief that challenges help us grow.

Fryberger’s learning environment is strengthened by strong family and community partnerships and an active PTA. PTA-sponsored events, including Trunk or Treat, Cookies with Santa, and Family Science Night, have become beloved community traditions that encourage engagement and connection. Our entire staff is highly qualified and deeply committed to student success, working collaboratively to ensure that Fryberger students thrive academically, socially, and emotionally in an ever-changing world.

2025-26 Quality, Currency, Availability of Textbooks and Other Instructional Materials

Westminster School District held a hearing on October 16, 2025 and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. The State of California. Core subject textbooks and instructional materials are provided for each student, including English Learners.

Standards-aligned texts and materials are reserved both for use in the classroom and to take home. All textbooks and instructional materials used within the school are aligned with California State Frameworks, State Board of Education, and District Standards.

Westminster School District is actively involved in the selection process of materials and textbooks. The selection process involves teachers, administrators, district support personnel, and parents. The district follows the State of California's Textbook Adoption Cycle, which requires every school site to review textbooks in each curriculum area within a seven-year cycle; textbooks are replaced at the rate of one subject area per year. The table contains a list of the most recent textbook adoptions in core curriculum areas for the school as of October 16, 2025.

School Facility Conditions and Planned Improvements

Cleaning Process & Schedule

The district governing board has adopted cleaning standards for all schools in the district. All schools are on a regular cleaning schedule. Each classroom is swept or vacuumed and the trash emptied. The cafeteria, multipurpose room, and all restrooms are cleaned daily. Grounds are groomed on a rotating basis, with trash, lawn, and plumbing issues addressed daily.

Maintenance & Repair

District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service that emergency repairs are given the highest priority.

Deferred Maintenance Budget

Annually, the district assesses deferred maintenance needs and creates a budget for each school site. Based on availability of funds, the district focuses on safety needs first and prioritizes other facilities repairs accordingly. Typically deferred maintenance repairs include roofing, plumbing, heating, air conditioning, electrical systems, paving and flooring.

Fryberger Elementary recognizes that strong family and community partnerships positively influence student success. Parents and community members are encouraged to participate in the many programs, activities, and organizations that support our students, including Student Council, School Site Council, Parent & Community Volunteers, and the Parent Teacher Association (PTA). School and district LCAP meetings are posted publicly and all stakeholders are invited to engage in shared decision-making.

We strive to create meaningful entry points for families to connect with the school. Parent conferences, Open House, and Back-to-School Night provide opportunities for families to learn more about their child's experience, ask questions, and offer feedback. Our active PTA and parent input nights ensure that a wide range of voices are included. Parent education workshops are held each trimester and cover topics such as digital safety, bullying prevention, supporting students at home, social-emotional learning, and Latino Literacy. Teachers communicate with families both in person and through technology and are available whenever families have questions.

Fryberger maintains a welcoming campus culture by hosting family-centered events such as Lunch on the Lawn, the Monster Mash, the Yard Sale, and Coffee with the Principal each trimester. Our counselor hosts a monthly coffee and discusses a wide range of topics with parents. Monthly Principal Newsletters help keep families informed about school news and PTA-sponsored activities. Volunteer opportunities are available throughout the year, and we are grateful for the participation that helps make Fryberger a wonderful place for students to learn and grow.

2025-26 School Safety Plan

Fryberger Elementary School offers a safe and secure campus for students, staff, and visitors. The school was built in 1964 and provides up-to-date facilities and adequate space for students and staff. Fryberger Elementary School is comprised of a transitional kindergarten/kindergarten area, library media center, large multipurpose room, and 27 classrooms. The school also enjoys a spacious playground with swings, a slide, play bars, and grassy fields for running, sports, and games. The school is also fortunate to have a large staff and family parking lot.

Fryberger Elementary School's Comprehensive School Site Safety Plan is reviewed annually to ensure the protection of students and staff, the school and school property, and to establish a climate that is conducive to learning. The School Safety Plan was approved October 6, 2025 by School Site Council members. The Board of Education approved the School Site Safety Plan on November 20th 2025. All staff members have copies of the plan and annually attend in-service days regarding school site safety policies. Drills are conducted to prepare for all types of emergencies. Students participating in in-person instruction are supervised throughout the day by classified employees and teachers.

Professional Development

Annually there are three district staff, classified and certificated, professional development days. The topics for these days are determined by the district level focus areas such as safety, curriculum adoptions and instructional supports as well as input from the staff for "voice and choice" session tailored to specific needs such as social-emotional supports and staff evaluations. In addition, the district provides monthly release time for professional teams to work and learn together. Certificated staff also participates in bi-monthly Wednesday professional development in either team professional learning communities or targeted professional training sessions. Instructional support specialists provide classroom coaching and professional development that is on-going throughout the year. District staff also attend conferences and outside training that is site determined such as behavior interventions and supports, AVID training, CGI, reading and writing conferences, technology conferences and GATE conferences.
