PLEASE NOTE

All use of school facilities is subject to the rules and regulations contained in board policy and administrative procedures, including Board Policy 4330 and Administrative Procedure 4330P. Copies of these documents are available from any school office or the District's Business Office.

DEFINITION OF CLASSES (from Administrative Procedure 4330P)

Class A users, "Non-district sponsored, non-profit users whose activities directly support or supplement the District's educational program," shall include non-profit groups or individuals which are not formed or subject to control by the District but whose primary purpose is to support Shoreline schools, programs and employees (such as the PTA, the Shoreline Foundation, and employee associations), or who offer activities which are consistent with and supplement the District's instruction of student embodied in state and local "essential learning" standards and in state law (such as youth academic clubs, youth athletic activities, and youth civic organizations).

Class B users, "Non-district sponsored, non-profit users whose activities do not directly support or supplement the District's educational program," shall include those non-profit groups or individuals who do not meet the definition for Class 2 users (such as governmental, civic, religious or charitable organizations when such groups are not providing activities which are consistent with and supplement the District's instruction of students).

Class C users, "Non-district sponsored, profit-seeking users," shall include all other groups or individuals not defined as Class B or Class C users.
