SURVIVING ASSAULT STANDING STRONG

LIABILITY, VIDEO, AND PHOTOGRAPHY WAIVER

During this course, participants will learn techniques to predict and prevent violence. Participants are taught to trust their instincts, recognize manipulative behaviors and how to use their voice and physical skills (including self-defense techniques) in order to get help. The course includes a discussion of mature subjects relating to assault, abuse and recognizing signs of unhealthy relationships.

SASS Go, a non-profit corporation organized under the laws of South Carolina, offer courses (identified below) in the SASS Program. This course teaches physical and mental techniques to predict and prevent violence and is taught for the use of legal self-defense only. I am aware of the physical nature and possible risks of injury from taking this course.
