RENEWAL LEVIES, NOT NEW TAXES

In February 2026, voters will be asked to renew the Richland School District's four-year Educational Programs & Operations and Capital Projects Technology Levies.

These levies were approved by voters in 2022 and are due to expire at the end of 2026. **They are renewals, not new taxes.**

WHAT DO SCHOOL LEVIES PAY FOR?

STUDENT LEARNING

Academic opportunities such as Advanced Placement, world languages, and courses that prepare students for college and career success.

STAFFING & CLASS SIZE

Levies fund 13% of certificated staff (teachers, specialists) and 16% of classified staff (office professionals, paraeducators), allowing for smaller class sizes and more elective opportunities.

ATHLETICS

100% funded by local funding. Covers costs for all sports programs, coaches, athletic directors, equipment, and travel for away games.

CURRICULUM & MATERIALS

Ensures students have access to up-to-date curriculum, textbooks, and hands-on tools that make learning engaging and relevant.

CLASSROOM TECHNOLOGY

Provides interactive tools and hardware, such as smart whiteboards, sound systems, and assistive technology, to help teachers create dynamic, hands-on learning experiences.

ENRICHMENT

Funds before- and after-school clubs, activities, and advisors, as well as travel for competitions, field trips, and other beyond the classroom experiences. Clubs are 100% funded by levies.

ART IN SCHOOLS

Supports creative electives and courses including visual arts, music, and drama, ensuring every student has the opportunity to explore and express their creativity.

STUDENT SUPPORT

Provides funding for counselors, social workers, school psychologists, and other professionals who support student well-being and success.

CYBERSECURITY & ONLINE SAFETY

Funds security systems, monitoring tools, and data protection measures that safeguard student and staff information and ensure safe learning environments.

STUDENT DEVICES

Supports the purchase, maintenance, and replacement of Chromebooks and other devices, ensuring every student has access to technology, no matter their economic background.

LEVY RATES

The Enrichment and Technology levies are not new taxes. They **maintain the current levy funding** already in place for our district.

The renewal enrichment levy rate would be \$2.50 per \$1,000 in assessed property value and the Technology levy rate would be \$0.50 per \$1,000.

PROPERTY TAXES

Per the Benton County Assessor, property taxes adjust annually based on assessed property values. However, the district **does not collect additional revenue beyond the approved school levy total**. The total levy amount voters are asked to approve is a fixed dollar amount.

As more homes are built within Richland School District boundaries, the levy amount is shared among more property owners, which may **reduce the amount each individual property owner pays**.



FREQUENTLY ASKED QUESTIONS



WHAT IF THE LEVIES DO NOT PASS?

Local levy funding makes up about 14 percent of the district's annual budget. **Without this local support, the district would need to eliminate approximately \$30 million from areas that directly impact students**, including classroom staffing, student support services, athletics, extracurricular activities and clubs, performing and visual arts, student wellness and safety, and technology and cybersecurity needs.

WHAT MAKES THIS A RENEWAL LEVY?

This is not a new tax. It renews an expiring local levy. This proposal renews the existing levy that is set to expire at the end of 2026. Our community has a long history of supporting school levies. Learn more at www.rsd.edu/levies.

IS THERE A TAX EXEMPTION FOR SENIORS AND LOW INCOME INDIVIDUALS?

Yes, there is assistance for low-income households. District residents should contact the Benton County Assessor's Office about their eligibility for a property tax exemption or deferral. Learn more at www.co.benton.wa.us.
