The St. Thomas Skill Center, established in February of 1977, served as a Virgin Islands Department of Education (VIDE) Adult Vocational Technical Education campus. On July 15, 1977, through legislative act #3993, the name changed to the Raphael O. Wheatley Skill Center in acknowledgement of the educator's dedication to the importance of the then vocational education. The mission was to equip residents with the technical and trade skills to meet the workforce needs of the US Virgin Islands. ROWSC is currently an accredited post-secondary career & technical education institute with twenty-two programs of study and several more on the drawing board.

Vocational Education traces back to over 125 years and originally referred to limited areas of vocational trades such as agriculture, carpentry, or trade and industrial education. Today, vocational education is Career and Technical Education (CTE) and provides skills that learners need to prepare for college, careers and lifelong learning. It offers students learning opportunities under 16 Career Clusters, which include over 79 different career pathways encompassing hundreds of careers with varying occupational entry and exit points for every learner. CTE marries the rigor of the academic with the relevance of the trade and emphasizes real world skills with anchored knowledge that is career focused.

The mission of the ROWSC is to provide learners with a unique and rigorous post-secondary Career & Technical Education (CTE) experience. This prepares them with the marketable skills and knowledge needed to enter the workforce and be competitive in the current emerging and changing global workforce, as well as to develop a passion for lifelong learning and become productive citizens.

The vision of ROWSC is to become a premier CTE College of the Virgin Islands that provides opportunities to perspective learners to pursue certification/licensure in the various career pathways, which promotes a seamless transition to the workforce, armed forces or high education.

## ADMISSION REQUIREMENTS

### Prospective students must:

- be 18 years of age or older
- have a high school diploma or its equivalents (*or enroll in our Dual Enrollment Program*)
- complete an application for enrollment
- provide a Health Certificate (*for certain programs as applicable*)
- provide a valid government issued ID with a recent picture (*i.e.: passport, driver's license*)
- provide a copy of up to date Immunization Record

Some courses require additional documentation

### The ROWSC will administer and require you to:

- take the Wide Range Achievement Test (WRAT) in Mathematics Computation and reading Comprehension
- complete an Emotional Intelligence Self-Assessment and Battery
- Complete two (2), three (3) hour Soft Skills seminar

## OTHER REQUIREMENTS:

### All students are required to:

- have basic digital literacy skills
- possess and bring to class, (where applicable) their own electronic device (*i.e.: laptop, iPad, Chrome Book, etc.*) {A cell phone is not acceptable.}

## CLINICAL MEDICAL ASSISTANT (CMA)

This program provides enrollees with the skills needed to effectively operate a range of medical back-office functions such as vital signs, body measurements, EKG's, assisting in minor office surgery, therapeutic injections, phlebotomy, assisting with physical examinations OB/GYN, patient education, and other duties associated with assisting medical professionals in procedures performed in a physician's office and medical groups. In the fourth semester, CMA students will gain hands on experience in the medical field participating in externships.

**TERM|** Two years (Four semesters)

**800 contact hours** (including 160 mandatory externship hours)

**TUITION|** \$500 per semester -- **Total \$2000**

**\$200 Application Fee** for new enrolles

**\$25 Registration Fee** per subsequent semester (nonrefundable)

Upon successful completion of this program, graduates will be eligible to take the National Registry Exam offered by the National Healthcareer Association and receive a nationally recognized industry credential. Graduates will also receive a Certificate of Completion from ROWSC endorsed by the Virgin Islands Department of Education.

The cost of required text or eBooks, uniforms and licensure/certification exams **are not** included in the tuition.

## EMERGENCY MEDICAL TECHNICIAN (EMT)

This program provides students with the skills needed to be a successful Emergency Medical Technician (EMT). EMT's are vital links in the healthcare profession. Students will learn the basic skills of ambulatory service and other specialized services. At the end of this program students will be able to recognize patients' conditions and the extent of injuries, perform inventory control; check all equipment and supplies; administer appropriate emergency medical care based on assessed findings of patients' condition, and how to properly engage lifting and positioning procedures to minimize discomfort and prevent further injuries.

**note** An Interview is required prior to acceptance into this course.

The cost of required text or eBooks, uniforms and licensure/certification exams **are not** included in the tuition.

## MEDICAL ADMINISTRATIVE ASSISTANT & BILLING AND CODING SPECIALIST

This program provides students with entry-level skills necessary to begin a career in Medical Administrative Assistant/Billing and Coding and Specialist. Students will learn how to develop and maintain complete, accurate records for patients at a healthcare facility. Students will be able to work in a variety of administrative positions within diverse healthcare settings. Courses include medical terminology, anatomy and physiology, billing and coding, processing of health claim forms, and computerized medical management. Graduates from this program will be eligible for entry-level employment as receptionists, accounts

receivable specialists, insurance claims processors, and billing and coding specialists.

**370 contact hours** (including 100 mandatory externship hours)

**TUITION|** \$500 per semester -- **Total \$1000**

**\$200 Application Fee** for new enrollees

Upon successful completion of this program, graduates will be eligible to take the National Registry Exam offered by the National Healthcareer Association and receive a nationally recognized industry credential. Graduates will also receive a Certificate of Completion from ROWSC endorsed by the Virgin Islands Department of Education.

The cost of required text or eBooks, uniforms and licensure/certification exams **are not** included in the tuition.

## PATIENT CARE TECHNICIAN (PCT)

This program prepares students for the Patient Care Technician (PCT) Direct Care Worker role in health care settings. Emphasis is placed on the personal qualities, knowledge, and skills needed by the PCT to provide exemplary basic care in a healthcare agency, or independent assistance to patients in the home setting under the supervision of Registered Nurses. Basic nursing and home health care, client rights, principles of therapeutic communication, safety, infection control, emergency situations, restorative care, death and dying, and legal/ethical issues related to nursing practice are introduced.

Phlebotomy & EKG's are key components of this program, coupled with classroom instruction, campus laboratory skills practice, and clinical laboratory rotations at the district's community health care agencies.

*note* The required pre-requisite for this program is completion of the Certified Nursing Assistant (CNA) program. Students who possess their CNA License from Virgin Islands Board of Nurse Licensure are only required to take one semester of this course, which includes the required minimum externship hours.

Upon successful completion of this program, graduates will be eligible to take the American Healthcareer Association PCT Certification Exam and receive a nationally recognized industry credential. Graduates will also receive a Certificate of Completion from ROWSC endorsed by the Virgin Islands Department of Education.

The cost of required text or eBooks, uniforms and licensure/certification exams **are not** included in the tuition.

## PHLEBOTOMY

This program provides students with the necessary skills to perform laboratory tests efficiently. Students will learn how to prepare slides, perform blood collection, handle emergencies effectively, and demonstrate competencies in patient care techniques. Utilizing hands on training, students will demonstrate venipuncture, dermal puncture and proper collection and transportation of blood specimens.

**TERM|** One year (Two semesters)

**330 contact hours** (including 100 mandatory externship hours)

**TUITION|** \$500 per semester -- **Total \$1000**

**\$200 Application Fee** for new enrollees

**\$25 Registration Fee** per subsequent semester (nonrefundable)

Upon successful completion of this program, graduates will be eligible to take the National Registry Exam offered by the National Healthcareer Association and receive a nationally recognized industry credential. Graduates will also receive a Certificate of Completion from ROWSC endorsed by the Virgin Islands Department of Education.

The cost of required text or eBooks, uniforms and licensure/certification exams **are not** included in the tuition.

## **CERTIFIED NURSING ASSISTANT (CNA)**

This program provides the students with strategies and techniques for feeding and dressing patients, as well as proper body mechanics for lifting and transferring patients. Lessons include recognizing depression, issues pertinent to abuse and neglect, dealing with dementia, infection control issues, and perineal care. The instructional modality will be didactic and hands on skills training in the classroom.

**note:** Graduates who receive their CNA certification from Virgin Islands Board of Nurse Licensure are eligible to enroll and take an additional semester of the Patient Care Technician (PCT) course for certification as a PCT.

## **LICENSED PRACTICAL NURSE (LPN)**

This program equips students with the knowledge and skills needed to work closely with patients and nursing staff to execute patient care plans, provide care and wound management, administer appropriate bathing, dressing and feeding techniques, monitor vital signs and report patient status and needs to nurses and physicians. Students will be qualified for employment in hospitals, nursing and/or assisted living homes, hospice facilities, correctional institutions and other long-term care facilities.

Six Semesters including summers (16 weeks per semester)

## COSMETOLOGY

This program provides students with beginning theoretical principles and practical procedures of cosmetology. Students will perform basic manipulative skills in the areas of hairstyling, cutting, coloring, texture services, scalp and hair conditioning, skin and make-up, manicures, pedicures, and nail extensions among others. Safety requirements, sanitary and sterilization measures are key elements in this course.

## BARBERING

This program teaches the foundations of Barbering. Students will learn about health, safety and hygiene, tool maintenance, sanitation and sterilization, the use of clippers, scissors and combs, hair and facial hair cutting techniques, shampoo, conditioning and treating the hair and scalp. As well as the styling and care of various hair textures, effective communication and customer service skills.

**TUITION** | \$500 per semester -- **Total \$1000**

Upon successful completion of this program, graduates will be eligible to take the licensure exam proctored by Professional Services Industries (PSI) through the Virgin Islands Department of Licensing and Consumer Affairs Board of Barbers, Beauticians, and Manicurists and earn a nationally recognized industry credential. Graduates will also receive a Certificate of Completion from ROWSC endorsed by the Virgin Islands Department of Education.

The cost of required text or eBooks, uniforms and licensure/certification exams **are not** included in the tuition.

## ESTHETICIAN

With more people seeking non-invasive skin treatments, this occupation is growing faster than others in the cosmetology and medical fields. An Esthetician's focus is on skin care, including but not limited to skin treatments, facials, superficial chemical peels, makeup application hair waxing and removal.

**In this program, some topics students will learn are:**

- skin analysis to determine clients' skin type, identify and treat a variety of skin issues
- diverse facial treatments such as exfoliation, massages, proper cleansing and toning of the skin
- effective make up techniques based on client's skin tone and condition
- body treatments such as masks, scrubs and wraps
- hair removal using waxing, tweezing, as well as eyebrow shaping
- the functions of the body, and the basics of skin anatomy and physiology.

## HAIR BRAIDING

This program provides students with the theoretical principles and practical procedures of hair braiding. It equips students with skills necessary for safe and sanitary natural hair braiding and effective use of extensions to include coverage of the key elements of the arts such as:

- sanitation and sterilization
- disorders and diseases of the scalp
- HIV/AIDS and other communicable diseases
- the laws and rules regarding Hair Braiding

(including 85 mandatory externship hours at a licensed salon)

**TUITION|** \$500 per semester -- **Total \$1000**

**\$200 Application Fee** for new enrolles

## MEDICAL MASSAGE THERAPY

The Medical Massage Therapy program covers the foundational and advanced technical skills to meet the Virgins Islands and Federation of States Massage Therapy Board qualifications. The curriculum prepares students for employment in the medical profession as medical massage therapists. Massage therapy is a holistic profession focused on helping people improve their physical and emotional well-being. Students learn in a hands-on

environment and gain a deep understanding of massage therapy through the integration of classic techniques including Swedish, deep tissue, and therapeutic massage. Anatomy & Physiology, Health & Hygiene, Pathology, Kinesiology, and Hydrotherapy are but a few of the topics included in this learning experience. Students will also have opportunities to engage in onsite clinical and classroom settings working with a variety of clients.

Students are prepared to work in a range of settings including private practice, physical therapy clinics, chiropractic offices, corporate/franchised spas, sports industry, and destination resorts.

Upon successful completion of this program, graduates will be eligible to take the Massage and Bodywork Licensing Examination (MBLEx) proctored by Professional Services Industries (PSI) through the Federation of State Massage Therapy Boards and earn nationally recognized industry certification. Graduates will also receive a Certificate of Completion from ROWSC.

The cost of required text or eBooks, uniforms and licensure/certification exams **are not** included in the tuition.

## NAIL TECHNICIAN

This program provides students with theoretical principles and practical procedures in nail care. Students will be trained in the effective techniques required to perform manicures, pedicures, advanced nails, nail art and nail maintenance. Advanced nails include instructions on tip application, gel, acrylic, sculptured, fiberglass, nylon and silk overlays.

**TERM|** One year (Two semesters)

**500 contact hours**

(including 85 mandatory externship hours at a licensed salon)

**TUITION|** \$500 per semester -- **Total \$1000**

**\$200 Application Fee** for new enrolles

**\$25 Registration Fee** per subsequent semester (nonrefundable)

Upon successful completion of this program, graduates will be eligible to take the licensure exam proctored by Professional Services Industries (PSI) through the Virgin Islands Department of Licensing and Consumer Affairs Board of Barbers, Beauticians, and Manicurists and earn a nationally recognized industry credential. Graduates will also receive a Certificate of Completion from ROWSC.

# Hospitality & Tourism Career Cluster

## CULINARY ARTS

In this program, students will learn the fundamental industry standards of food handling, preparation, safety, nutrition, and restaurant operating procedures. Additionally, students will receive ServSafe training. ServSafe is a nationally recognized food safety-training program designed by the National Restaurant Association (NRA) educational foundation, and is a mandatory component of the course that requires taking an exam accredited by the American National Standard Institute (ANSI) for ServSafe certification. ServSafe is the prerequisite education for restaurant workers and other food handlers about the best practices in food safety, as sanitation and safety certification are required by most restaurants as a basic credential for their management staff.

## COMPUTER APPLICATIONS

This program provides students with an introduction to basic through advanced computer concepts and essentials. Students will learn important computer skills necessary for employment. Students will be introduced to internet search techniques and email as well as the array of the Microsoft Office Suite such as:

- Word
- Excel
- Access
- PowerPoint

## AUTOMOTIVE BODY REPAIR

The Automotive Body Repair program provides enrollees with the skills and knowledge to properly repair the body and structure of a vehicle, become familiar with the process of inspecting and identifying previously repaired vehicles, as well as provides an introduction to frame pulling, using a paint booth, welding and dent repair.

## AUTOMOTIVE MECHANIC

The Automotive Mechanic program provides students with the skills and knowledge to properly maintain and repair both imported and domestic vehicles. Students will be introduced to simple engine systems and performance machines and will learn fundamental Auto Engine Repair, Automatic and Manual Transmissions and Transaxles, Auto Suspensions and Steering, Brakes, Electricity and Electronics, Heating and Air Conditioning, Engine Performance and Drivability, as well as how to utilize the various equipment, tools of the trade and understand their functions.

## ELECTRICAL VEHICLE TECHNICIAN

This is a dynamic training course designed to equip students with the essential knowledge and hands on skill required to safely service electric vehicles. The curriculum emphasizes high voltage safety, diagnostics, maintenance, and repair of key EV systems such as drivetrains, battery packs, and control modules. Instruction is delivered through clear engaging materials and practical lab activities.

A unique feature of the program is the opportunity for the students to assemble a kit electric vehicle, reinforcing theoretical concepts and enhancing real world skills. The course also explores emerging EV technologies and industry trends, ensuring students are prepared for the evolving automotive landscape. Training includes classroom instruction, lab work, and a structured externship at professional EV repair facilities.

**note:** The program is offered in two tracks: a one-semester accelerated track for students with prior EV knowledge and a two-semester pathway for beginners. Total contact hours range from 240 to 480, depending on the selected track.

This program provides students with knowledge and training in air-conditioning, hydronic heating, temperature and humidity control, air circulation, ductwork and pipe system control, design and layout, thermostat ventilating equipment, automatic controls, commercial and household refrigeration, layout and installation and pipe practices. Students will learn to install and repair equipment in the lab segment of this program. A combination of practice and theory will prepare students for employment and advancement in today's HVAC/R industry.

Students will also learn about the materials, and fixtures utilized in the installation, maintenance, extension and alteration of all piping, fixtures, and plumbing appliances. Students will learn the types of construction drawings typically used in the plumbing trade and how to read, interpret, and sketch construction drawings, as well as how to draw lines to scale, and safely use, properly care for and maintain basic plumbing tools of the trade. They will learn and utilize some of these tools to measure, lay out cut, drill, bore and ream. Students will learn about applicable local and national code requirements, as well as the most common types of plumbing fixtures and how they operate.
