PAYMENT INFORMATION

Annual Enrollment

Deposit

The required annual enrollment deposit due in January, 2026 is as follows:

- Early Childhood Program: A set amount
- Kindergarten – Grade 8: 10% of the expected tuition
- Grades 9 – 12 (Day): 10% of the expected tuition
- Grades 9 – 12 (Boarding): A set amount

In the case of more than one child enrolling per household, a reduced deposit is charged after the first child.

Tuition Refund

Insurance

Tuition Refund Insurance is optional and can be purchased during the enrollment or re-enrollment process through Dewar, an independent third party organization. Premiums are 2.8% of tuition, Pre-School after care (if applicable), and net of any financial aid award. Tuition Refund Insurance must be purchased prior to July 1 of enrollment school year. Tuition Payment Plans

A. One (1) Full Payment: Pay one payment of 100% of the tuition and fees on or before **May 20, 2026** via Veracross Pay (VC Pay) in your portal. International families and those living outside the United States are required to use this option. The School accepts international payments via FlyWire.

B. Two (2) Equal Payments: Pay two equal payments on or before **May 20, 2026** and **Oct. 21, 2026** via VC Pay. Please note that a one-time \$200 surcharge will be added to each student’s account for this option.

C. Ten (10) Monthly Payments: Pay 10 equal monthly payments beginning no later than **May 20, 2026** and ending no later than **Feb. 20, 2026**. Please note that a one-time \$600 surcharge will be added to each student’s account and registration in autopay via VC Pay is required for this option.
