Ruben Garcia, community member, stated that the current administration created an unsustainable work climate. He stated that comments made at the last meeting insulted most teachers as it weaponized a sentiment that most of them believe in.

Valerie Rios, DAEP teacher, addressed the Board responding back to the Superintendent’s comments made at the last meeting, which included her work practices last year.

TEA REMARKS

Dr. Abe Saavedra, TEA: Well happy holidays! Friday will be 10 months that you were placed in your position, the 19th of December. I just wanted to reflect a little bit on what’s gone on the last ten months. The main reason for the placement of the Board of Managers was really governance issues and I can tell you that as a governing board y’all have done an excellent job these last 10 months supporting the administration. As the administration brings change to the system. I know the change is difficult and I know that not everyone supports the change that’s occurring but I will remind you that things don’t improve unless things change. I’m sure there will be a balance that you will identify as you go through this process but I can tell you that as I’ve looked at some

preliminary data things are starting to look good. As a matter of fact I am scheduled January 22 to do a presentation to the commissioner concerning the data for South San as to what's occurred up to this point. of this school year. And like I said, the preliminary numbers that I've looked at they are looking good and I have no doubt that by the end of the school year this district is going to be performing at a very high level of performance. And you have several more years to go after that. The reason that the Commissioner places a Board of Managers in place, and as a reminder, there is only 5 districts in this state out of 1,200+ districts, only 5 districts have a Board of Managers right now. It's a real significant change for a school system to put in a Board of Managers. The end result is that there needs to be high performance resulting from that. And the change that needs to occur is gonna have to be very significant change. For there to be significant improvement the change has got to be significant as well. And I wanted just to reflect with you a little bit because like I said its been 10 months and from a performance point of view things are looking well. So I wish the very best, have a blessed holiday season thank you.

SUPERINTENDENT'S REMARKS (NO ACTION / REPORT ONLY)

Dr. Saul Hinojosa, Superintendent of Schools, addressed the Board and audience regarding his visit to DAEP which had 100% attendance this week. He stated that he has stepped into every classroom as of this week. He stated that a couple teachers he may not have seen if they were on FMAL for some reason, but has been to every classroom. He said he has seen a significant change in classrooms. He thanked all of the teachers and administrators for working so hard because every student deserves the highest quality education. He stated that he is drawn to the family type of atmosphere, people coming together to bring happiness to every family here. He said we received a \$5,000 donation from HEB for STEM education. He informed that we received a \$12,000 donation from Frost Bank to fund next year's convocation and we received a \$25,000 for STEM education as well. He said we have a lot of partners such as Harvey Najim donated all proceeds and food for 663 families. He stated that this past Saturday the students were able to get a gift at the Winter Wonderland from partners such as Fernandez Honda. He wished the whole community a Merry Christmas and let the audience know we will be returning in 2026. He stated when we return we will continue to make great things happen for our students.


ADJOURNMENT
