Tuition Obligation: The full year's tuition charge is due and payable regardless of early withdrawal or dismissal unless a withdrawal form is submitted prior to June 1st. Withdrawals in May are obligated to pay half of the upcoming year's tuition. Refer to the enrollment contract for important stipulations.

Tuition Deposit: A non-refundable deposit of \$1,500 is due annually upon registration for new and returning students and is applied as a payment toward tuition.

Tuition Refund Insurance (TRI): TRI is optional for families choosing to pay in full and required for those choosing an installment plan.

New Student Fee: A new student fee of \$1,500 is required for all new students. This is a one-time non-refundable fee due upon acceptance. It does not apply to returning students who have completed an Evergreen Enrollment Contract.

Other Costs: The tuition fee includes the cost of attendance, required educational materials, technology, and field trips. It does not include optional Extended Day and After School Activities. Uniforms and lunches are provided by third-party partners and are excluded from tuition.

Late Fees and Returned Payment Charges: A late fee the greater of \$50 or 1.5% of the outstanding balance will be assessed for tuition payments received 10 business days beyond the due date and for every additional 30 days past the due date. A \$50 fee will be charged for each returned check or EFT returned payment.

Delinquent Accounts: Students with delinquent accounts will not be allowed to start school. Students may not attend school or participate in school activities and grades and records may not be released if an account becomes 60 days delinquent.
