## 2025-26 School Description and Mission Statement

Charles Peck Elementary is one of 41 elementary schools in the San Juan Unified School District and proudly serves as a Title I school. Thanks to the district's participation in the Community Eligibility Program, all of our students receive free meals.

Our mission is to work collaboratively with staff, parents, and the community to ensure every student gains the foundational skills, knowledge, and growth mindset needed to reach their full potential. We maintain high expectations for all students, believing that every child can succeed when provided with appropriate instruction in a supportive, safe environment. Our curriculum is aligned with the Common Core State Standards (CCSS), and we foster cultural awareness daily through inclusive, academically and culturally responsive teaching practices.

At Charles Peck, we focus on educating the whole child—academically, socially, and emotionally. We use ongoing assessments and research-based practices to guide instruction, sharing academic progress with families throughout the year via newsletters, progress reports, conferences, and various communication channels. Our school utilizes funding from Title I, LCFF, and ELO/ELRBG to support key programs, including full-time Intervention Teachers, a full-time counselor, staff development, and classroom technology. Additional resources come from the ELO/ELRBG Grant, which an additional Intervention Teacher. All classrooms are equipped with digital presentation tools, an Apple TV, and our K-5 students have access to iPads and/or Chromebooks. A dedicated full-time ELD Specialist supports English Language Learners through classroom instruction and small-group interventions.

Key Programs Supporting Student Learning:

We implement several programs to support grade-level, standards-based instruction, including:

ELA: Benchmark for reading and writing, i-Ready lessons and diagnostics, Scholastic Guided Reading, and the mClass/DIBLES progress monitoring.

Math: Envision Math and i-Ready for Math

Other Support Tools: Raz Kids, GLAD strategies, Lexia, Heggerty Phonics, ESGI, and additional research-based practices

Behavior Support: Positive Behavior Intervention Support (PBIS): A Little Spot of Emotions/Feelings, Strong Kids, and Zones of Regulation. These programs promote positive behavior through explicit instruction, recognition, and natural consequences.

We collaborate with the Student Support Center to provide data-driven, multi-tiered interventions, ensuring every student

receives the appropriate level of support. The Bridges After-School Program offers extended care with enriching activities until 6 pm. Safety remains a top priority, and we conduct regular emergency drills, update safety protocols, and include safety topics in our monthly staff meetings.

We foster a college-bound culture and promote character traits such as safety, respect, responsibility, citizenship, fairness, and friendship.

## 2025-26 Quality, Currency, Availability of Textbooks and Other Instructional Materials

San Juan Unified held a public hearing on September 23, 2025 and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. # School Facility Conditions and Planned Improvements

## General

The Board of Education and the Superintendent's policy is to ensure that all students are provided with a safe and well-maintained learning environment. The board approved resolutions in 1998 and 2002 to adequately fund maintenance activities and preserve the repairs and improvements funded by two facility bond measures. District maintenance staff ensure repairs necessary to keep the school in good repair and working order are completed in a timely manner. A computer automated work order process is used to ensure efficient service and that emergency repairs and health and safety repairs are given the highest priority. The Board of Education has adopted cleaning standards and custodial staffing requirements for all schools in the district. This school meets the Board's standards for custodial staffing and cleanliness. The school's custodians are trained in the proper use of cleaning chemicals and Integrated Pest Management techniques. They are managed day to day by the principal with assistance from the district's maintenance department. The district participates in the State School Deferred Maintenance Program, with funding allocated for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems. Annually the district budgets \$2 million dollars for deferred maintenance activities. This school contains 18 classrooms, and 10 other student or administrative spaces as well as 3 playgrounds.

## Maintenance and Repair

LEA maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient services and that emergency repairs are given the highest priority. Emergency work orders are addressed in the first 24 hours. Routine work orders are addressed within 30 days.

## Cleaning Process and Schedule

The LEA governing board has adopted cleaning standards for all schools in the LEA. Each site has a day and evening custodial crew. Each crew member has a run sheet with assigned responsibilities. A copy of these run sheets is available at the school office or can be obtained from Maintenance and Operations Custodial Services. Custodial Area Supervisors oversee the cleaning of all district sites to ensure cleaning standards are met daily providing a clean and safe site.

## Deferred Maintenance Budget

The LEA participates in the State School Deferred LEA maintenance Program, which provides state matching funds on a dollar-for-dollar basis to assist LEAs with expenditures for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting and floor systems. For the 2023-24 school year, the LEA has budgeted 2 million for the deferred maintenance program. This represents 3% of the LEA's general fund budget.

##### Parent Engagement

At Charles Peck School, we actively encourage and value parent and community involvement as essential partners in our students' educational journey. One key avenue for this engagement is the Charles Peck School Site Council (SSC). Comprised of an equal number of parents and school staff, the SSC plays a critical role in developing and monitoring the School Improvement Plan. This plan focuses on enhancing student literacy and mathematical skills, integrating technology in learning, fostering a positive and inclusive school climate, and ensuring equity for all students, especially those from marginalized groups.

In addition, we provide regular communication through the Charles Peck Newsletter, a digital bulletin designed to keep families informed about school activities, events, and parent education opportunities. The newsletter offers translation capabilities through a drop-down menu, making it accessible to all families. It includes articles on important topics such as safety protocols, curriculum updates, effective routines, and upcoming events. We also provide opportunities for parents to offer feedback and express their voices within the school community.

Classroom teachers complement this communication by sending home newsletters and informal progress notes. Families are regularly updated on their child's progress through a variety of means, including formal and informal parent conferences, progress notices, report cards, phone calls, emails, and notes. Additionally, we use Talking Points, a two-way communication platform, to further support meaningful parent and community engagement.

We encourage parents to volunteer their time and talents to support school events such as the 100 Day Celebration, Family Events, ongoing SSC activities, fundraisers, and field trips. Leadership and advisory opportunities are also available through the English Learner Advisory Committee (ELAC), Parent/Principal meetings, and School Site Council meetings. These events focus on student academic achievement, offering resources and support, and promoting positive character development. Parents are required to complete the fingerprinting process in order to chaperone students during field trips.

Our strategic plan emphasizes the importance of parent and family involvement in maintaining our professional learning community's focus on achieving academic and social success for all students. By participating in school committees, leadership teams, and activities, families contribute directly to the success of our school's mission.

## 2025-26 School Safety Plan

### School Safety Plan

San Juan Unified School District emphasizes school safety and understands its importance in helping to achieve the academic success of its students. In accordance with the California Education Code, each school site must complete and maintain a Comprehensive School Safety Plan, to be reviewed and updated annually. The plan includes a review of safety data for the campus, safety policies, critical incident response & management information as well as emergency procedure information including those pertaining to incidents involving fire, earthquakes, intruders and other dangers. The review and update of the plan is a collaborative process involving representatives from site administration, instructional staff, custodial & classified staff, safety personnel and parent representative who together comprise a site safety team. Finalized plans are posted to site webpages for public access and presented to staff during training and development days no later than March 1 of each year. A copy of the plan is available for review in each school site office.

Safety drills are held on a regular basis and in compliance with the California Education Code to include fire drills, earthquake drills and intruder drills. Drills are coordinated and monitored with the assistance of the trained district safety personnel.

Safety is a shared responsibility. Each school site is supported by the district's Safe Schools Team. The Safe Schools Team is comprised of personnel specifically trained to support and promote school safety, provide advice to matters involving student welfare, assist in the coordination of drills and provide safety training to students and staff. Safe Schools Team members, known as Community Safety Specialists, work collaboratively with site administrators and safety committee members to build and strengthen a culture of safety as well as address specific incident needs. The Safe Schools Team members are further supported through developed relationships with local law enforcement offices including the Sacramento County Sheriff's Department & Citrus Heights Police Department. As needed, San Juan Unified utilizes contracts with local law enforcement for the purpose of employing uniformed law enforcement officers to further enhance school site security for special events as well as in response to critical incidents and threats.

## Professional Development

Professional development is a key part of the continuous improvement process for educators. The goal of our quality professional development is to support the learning of teachers and paraprofessionals to positively impact student achievement. Annually, teachers and site administrators participate in professional development in a variety of opportunities. Eighteen hours per year are dedicated to staff collaboration and professional learning planned by site leadership teams. The District also provides a cycle of continuous professional development for Administrators through Principal Meetings and Principal Networks.

The District provides professional development opportunities for teachers and administrators that support the implementation of grade level standards in English language arts, mathematics, science, social studies, and the ELA/ELD Framework. Specific professional development initiatives include: Culturally Responsive Practices, TK-2 Reading, and the California Mathematics Framework. District departments, Center for Teacher Support, grant-funded projects, and the San Juan Teacher's Association sponsor additional training opportunities. Professional development opportunities are voluntary for teachers and are provided throughout the year in a variety of formats: during the school day, after school, on Saturdays, and during summer and vacation breaks. Many teachers and administrators also take advantage of opportunities with Sacramento County Office of Education, California Department of Education, the college/university programs, state/national education organizations, and private educational institutes.

What grounds the professional development in the district is the District Strategic Plan and the Local Control Accountability Plan. Professional Development is further determined using one or more of the following: (a) student achievement data, (b) staff survey data, and (c) district-identified goals. Professional development addresses the grade level standards, teaching strategies, curriculum, assessment, technology, classroom management, safety, and leadership. Administrator training accompanies professional development in district focus areas, providing implementation support for teachers on site. Content-area coaches are available at some schools. Additional classroom support is provided to new and struggling teachers by consulting teachers from the Center for Teacher Support.

Paraprofessionals are encouraged to participate in professional development at the district and site level. Specifically designed training is also offered to non-instructional support staff such as clerical and custodial staff that includes both operational and instructional topics.
