Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. School Facility Conditions and Planned Improvements

General: The district places a strong emphasis on ensuring that all schools are safe, clean, environmentally friendly, mechanically functional and inviting for students, staff members, and the community. To assist in this effort, the district utilizes the Facility Inspection Tool (FIT) developed by the State of California OPSC and local operations department developed inspection survey methods to keep facilities in compliance with all federal and state health and safety regulations. The district regularly inspects and reviews the condition of the school facilities and surrounding grounds. The district places the highest

priority on those safeguards that impact the fire, life and safety protection of the students, staff, and school buildings. Below is more specific information on the condition of the school and the efforts made to ensure that students are provided with a clean, safe, and functional learning environment.

Age of School Buildings: Eldridge was constructed in 1956. This school has thirty-two (32) regular classrooms, a multipurpose room, a library, and an administration building. In addition to the main building, there are thirteen (13) portable classrooms that have been added to accommodate class size reduction and instructional programs.

Maintenance and Repair: District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order system process is used to ensure efficient service and highest priority is given to emergency repairs. At the time of publication, 100% of the school's restrooms on campus were in good working order.

Cleaning Process and Schedule: The district has developed cleaning standards and schedules for all schools in the district. A summary of these standards and schedules is available at the school or the Maintenance & Operations office. The principal, with the guidance of the Facilities, Maintenance, Operations and Transportation (FMOT) Department works daily with the custodial team to ensure that the cleaning standards are met, and that classrooms, restrooms, and campus grounds are kept clean, safe, and well-maintained.

Modernization Projects: Since 2019, local bond funds (Measure H) are being used to complete various modernization and infrastructures projects throughout HUSD. At Eldridge Elementary these projects have included replacement of the roof system and exterior painting of the school. All work described was completed by the end of the 2020 summer period.

Parents are able to participate in our Parent Teacher Organization (PTO), School Site Council (SSC), Site Based Decision Making (SBDM), English Language Advisory Committee (ELAC), African America Student Achievement Initiative (AASAI) and Coffee with the Principal. Along with these committees, Eldridge is also a Community School. Eldridge employs a school site Family Engagement Specialist who helps to schedule parent workshops, family events, and school wide events. In partnership with our families we can ensure that all Eldridge students work to their full potential.

Eldridge has an on-site Family Engagement Specialist. Our Family Engagement Specialist encourages and coordinates parent education and involvement in various District and school programs and other activities to ensure equity of opportunity and access; perform liaison duties among staff, community resources and parents; refer families to local agencies or services as appropriate; utilize and update designated District communication and outreach portals and protocols. Working closely with our Family Engagement Specialist, Eldridge also employs a Community School Specialist. Our Community School Specialist works to bring in community resources to help support our students and families. Along with supporting our families with additional resources, our Community School Specialist is co-chair of our our Community School Grant and is working with school staff and families the on allocation of grant funds.

The school's disaster preparedness plan includes steps for ensuring student and staff safety during a disaster. Eldridge Comprehensive School Safety Plan was approved by SSC on 10/22/25

Safety is a high priority because it is necessary to ensure a successful and healthy educational environment. Students are supervised throughout the day by teachers, administrators, and other campus supervisors. There are designated areas for student drop-off and pick up. Visitors need to check in at the front office and receive a badge.

Fire, disaster, and lockdown drills are conducted on a regular basis throughout the school year so that all staff and students are familiar with what steps to take in an event of an emergency. The school is using an online application called Share911 to communicate with staff during emergencies. This online safety app is also used to coordinate safety/disaster drills. Our school's Comprehensive Safety Plan has been reviewed and discussed during staff meetings and parent meetings (such as SSC, Coffee with the Principal).

Fiscal Year 2024-25 Types of Services Funded

Eldridge is a Title I school which receives state and federal funding to support our students. Our students receive free breakfast and lunch during the school day.

To help serve and support our community, Eldridge has a Community Support Specialist and a Family Engagement Specialist who work closely with families and the community to bring in resources, host special events, and facilitate education classes for families. Eldridge also has a full time counselor to help support the socio-emotional needs of our students. Eldridge also funds a 0.50 FTE intervention teacher, during the school day, to help support our students in ELA and Math through small group instruction (outside of students homeroom).

Youth Enrichment Program (YEP) offers before school and after school programming at Eldridge. YEP gives students opportunities for homework/academic support and to expand their learning through fun recreational, athletic, and educational activities. Students grow socially, emotionally and physically, build community and belonging, develop confidence and resilience, and have fun in a safe supportive environment.

Professional Development

This section provides information on the annual number of school days dedicated to staff development for the most recent three-year period.

As part of the growth process, opportunities for training and staff development are provided at both the district and individual school sites to administrators, teachers, and classified staff. The school provided two full days of professional development on August 12 and 13, 2025. The district offered an additional staff development day on November 3, 2025 for a total of 3 staff development days in the 24/25 School Year. The curricular focus of the current school year is ELA with a focus on small group instruction and culturally relevant literature. In addition Hayward Unified School District is also coordinating minimum days to provide ongoing professional development.

Our work on Common Core Mathematics/ELA teaching and learning is supported by administration, instructional coaches and grade level teams. We've also focused on Equity and Deeper Learning in order to engage our students and support them to develop critical thinking skills. Another important focus is Culturally Responsive Teaching. Our staff is currently being trained to better understand and serve the many different cultures that are part of our community. CRT is at the core of what we do at Eldridge.
