1. Terms and Conditions

By enrolling your child in the Inter-Community School Zurich (hereafter named ICS), parents/guardians agree to comply with the terms and conditions and the schedule of fees described in these Financial Regulations. These Financial Regulations supersede all former financial agreements between the parties. Parents/guardians who wish to apply for a place for their child(ren) may do so by following the online application process.

Please note that the Financial Regulations are updated annually.

1.1 Application Fee

An Application Fee of CHF 500 is due for each student new to ICS or returning after leaving the school. Applications will not be considered until the Application Fee is paid. Kindly note that it is non-refundable and is paid online by credit card (MasterCard or VISA).

1.2 Capital Fund Fee

The Capital Fund Fee of CHF 5'000 (Nursery CHF 1'000) is used for the continual enhancement of the school environment. CHF 1'000 is due for each new student upon accepting an enrolment offer. The Capital Fund Fee is non-refundable. Children moving from Nursery to Pre-Kindergarten will be invoiced CHF 4'000 with the first Tuition Fee invoice. Returning students are only liable for the difference between the Capital Fund Fee originally paid and the fee at the time of re-entry.

1.3 Tuition Fee

Annual Tuition Fees include:

- Essential educational materials and books
- Access to computing devices from Grade 3 to 8
- Up to four periods per week of additional learning support
- Mandatory curricular trips; IB/DP exams
- Other fees which are not included in the Tuition Fee are defined under “Other Fees”, see [section 2.1](#).

1.4 Payment of Tuition Fee

The first portion (60%) of the Tuition Fee is due in August 2026; the second portion (40%) is due in January 2027. For information on an optional instalment plan with an administration charge of 2%, please contact the Finance Office (billing@icsz.ch). In exceptional cases, alternative payment arrangements may be granted to private payers for a period of one year, provided that a written request is submitted to billing@icsz.ch no later than 31 May 2026.

No refund of fees will be issued regardless of absences due to family, public or other holidays, illness or accident, as well as in the event ICS is forced to close temporarily due to circumstances beyond the school's control. In the event that a student is permanently excluded from the School, we will not grant any refunds for services due or already rendered. Parents/guardians are responsible for complying with all financial matters, regardless of the billing address. All invoices are due according to the terms stated on each invoice.

1.5 Administrative Charge

An administrative charge of CHF 2'000 will be applied in case a student is withdrawn before the start of the school year, after having confirmed her/his re enrolment for the upcoming academic year. This does not apply to the Nursery.

For Nursery, if a notice of withdrawal is given less than 2 months before the start of the contract, a cancellation fee of CHF 200 will be charged.

1.6 Late Enrolment

For student late enrolment the Tuition Fee is prorated monthly (11 months from August 2026 to June 2027) as per the first day of each month, plus an enrolment surcharge of 5% of the Annual Fee. This does not apply to the Nursery.

1.7 Early Withdrawal

Early withdrawal must be made in writing with a notice period of two months to the end of the month. For the preceding months and including the month of withdrawal, the tuition fee will be prorated monthly (11 months from August 2026 to June 2027) as of the last day of each month, plus a withdrawal surcharge of 10% of the Annual Fee. Students' withdrawal must be confirmed in writing to admissions@icsz.ch. For Children enrolling to the ICS Nursery programme, a two-week familiarisation period is granted. Thereafter, a child's withdrawal from the Nursery must be made in writing to admissions@icsz.ch, observing a notice period of one month to the end of the month. If no notice is received, the month during the cancellation period will be billed.

1.8 Late Payments and Outstanding Debt

- 1.8.1 A late payment charge of 2% per month will be applied to any past due balance.
- 1.8.2 If monthly instalment payments are not received by the due date set out, ICS reserves the right to set due the full amount.
- 1.8.3 ICS has the right to refuse entry to class and final examinations, and to withhold diplomas, reports and transcripts of students if payment remains outstanding following two written reminders.
- 1.8.4 A student may not be allowed to graduate unless all outstanding balances have been settled. All other arrangements for payment must be approved in writing by the Head of School.

1.9 Tuition Fee Remission

ICS may grant a limited tuition fee remission to students in exceptional circumstances for one year only. Remission requests can only be considered after completion of a student's first year at ICS. The deadline for applying for a tuition remission for the full school year or the Autumn semester is 31 May; the deadline for applying for a tuition reduction for the Winter / Spring semester is 31 October.

1.10 Data Protection

ICS may collect data relating to enrolment and tuition. It respects the Swiss data protection legislation as well as the European general data protection regulations and will treat that information confidentially. In case of an unpaid invoice, third parties may be engaged by ICS for the recovery of any outstanding fees and costs. For this purpose, ICS reserves the right to forward the necessary personal data to the relevant third-party.

1.11 Insurance

Parents/guardians must maintain health, accident and liability insurance for each child enrolled at ICS.

1.12 Amendments

ICS reserves the right to amend these Financial Regulations and the Schedule of Fees as deemed necessary. The Schedule of Fees is updated on a yearly basis, upon approval by the Board of Trustees.
