

**SPRING-FORD AREA SCHOOL DISTRICT VOLUNTEER AFFIDAVIT**

A Spring-Ford Area School District volunteer who has been a resident of Pennsylvania during the entirety of the previous ten-year period does not need to submit a Report of Federal Criminal History Record if this Volunteer Affirmation is completed.

I, \_\_\_\_\_ (print name), would like to serve in the position of an unpaid volunteer for the Spring-Ford Area School District. Under penalty of law, I affirm that I have been a Pennsylvania resident during the entirety of the ten-year period prior to my signing this Volunteer Affirmation. I am aware that the Spring-Ford Area School District will be relying upon this Volunteer Affirmation for the purpose of complying with the Child Protective Services Law (“CPSL”). I further affirm that I am not disqualified from service as a school volunteer by reason of having been convicted of any of the following offenses under Title 18 of Pennsylvania Crimes Code or of an offense similar in nature under the laws or former laws of the United States or one of its territories or possessions, another state, the
