11. Authorize the Superintendent to approve all applications for federal, state, and local funds;
12. Utilize the following newspapers for advertising and announcements: *Lorain County Community Guide (formerly The Wellington Enterprise), The Lorain Morning Journal, The Chronicle Telegram, The Ashland-Times Gazette and The Rural Urban*;
13. Purchase property, fleet and liability insurance as in the past;
14. Renew the OSBA membership for 2026;
15. Notification of medical insurance availability to the Board at 100% their cost per ORC 3313.202;
