DO NOT OPEN THE DOOR. ICE may lie about who they are and has been known to impersonate police and probation.

NO ABRA LA PUERTA. La MIGRA miente sobre su identidad y impersona policas y oficiales de probation.

Ask them to present a warrant. DO NOT OPEN THE DOOR without a warrant.
