2.1 Budget Information and Planning **Mrs. Lucero took us through the Staff Survey information and the approximate costs for all the academic and technology items from our staff suggestions. We also went over all the other possible situations for other needs for our next year's budget. We had a great question and answer session about how the positions we put into the budget will benefit Rhodes and how we can utilize the position for next year. We then made final decisions on Budget to submit to CCSD Once Budget is approved through CCSD, it will be available at our Betsy Rhodes Website.**

2.2 School Performance Plan Discussion and Planning: **Our 2020-21 SPP is due February 20th, however we will not have enough sufficient data to make any major changes at this time. The only new data we have which we will need to make adjustments and changes to our 2019-20 SPP is our current MAP assessments. Mrs. Lucero will be working with the CCSD School Improvement Department on which sections of our SPP need to be adjusted now. We plan to meet in the Fall and make final adjustments to our SPP once we receive more detailed data from our Rhodes test scores this coming Spring 2020.**
