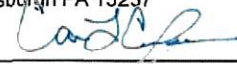

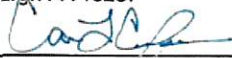

Resolution 2026-2 – Deputy Tax Collectors

**FOX CHAPEL AREA SCHOOL DISTRICT**

**RESOLUTION No. 2026-2**

**A RESOLUTION OF THE FOX CHAPEL AREA SCHOOL DISTRICT  
APPROVING APPOINTMENT OF JORDAN TAX SERVICE, INC.,  
TO COLLECT SCHOOL DISTRICT TAXES FOR THE BOROUGH OF  
FOX CHAPEL AND SHARPSBURG AND THE TOWNSHIP OF O'HARA  
AND DESIGNATING DEPUTY TAX COLLECTORS FOR THE  
BOROUGH OF BLAWNOX AND THE TOWNSHIP OF INDIANA**

**WHEREAS**, Tax Collectors have been duly elected in the Boroughs of Aspinwall, Blawnox, Fox Chapel, and Sharpsburg, and the Township of Indiana who are empowered to collect school district taxes through fiscal year 2028-2029;

**WHEREAS**, the elected Tax Collectors for the Boroughs of Fox Chapel and Sharpsburg, have appointed Jordan Tax Service, Inc., as Deputy Tax Collector authorizing Jordan to perform all duties and function of the Tax Collector, including collection of school district real estate taxes, the same as if Tax Collector were performing said duties and functions;

**WHEREAS**, the O'Hara Township Home Rule Charter allows its council to designate a person or entity to collect township taxes;

**WHEREAS**, on October 14, 2025, O'Hara Township Council approved the appointment of Jordan Tax Service, Inc., as Deputy Tax Collector to collect taxes, including real estate taxes; and,

**WHEREAS**, in connection with its appointment by O'Hara Township, Jordan tax Service, Inc. has agreed to collect school district real estate taxes for properties within O'Hara Township;

**WHEREAS**, Section 22 of the Local Tax Collection Law, 72 P.S. § 5511.22 provides that “[a] tax collector may, with the approval of a taxing district and his surety, deputize in writing one or more deputy tax collectors, who, when so deputized, shall be authorized to receive and collect any or all of the taxes in like manner and with like authority as the tax collector appointing them. Any tax collector, appointing any deputy collector, shall be responsible for and account to the taxing district for all taxes received or collected by his deputy.”

**NOW THEREFORE, BE IT RESOLVED** by the Board of School Directors of the Fox Chapel Area School District that the appointment of Jordan Tax Service, Inc., as Deputy Tax Collector for school district real estate taxes for the Boroughs of Fox Chapel and Sharpsburg and the Township of O'Hara is approved, subject to the written approval of the Tax Collector's Surety.

For its services, the annual compensation of Jordan Tax Services, Inc., shall be \$3.75 per tax bill for the Fox Chapel Area School District Taxes for each locality, plus any postage increase after December

31, 2026, paid annually within thirty (30) days of the date of invoice paid directly to the Deputy Tax Collector. Each annual period shall end on December 31 during the Tax Collector's term of office. The Deputy Tax Collector may also charge \$10 per year certified for tax certifications. The Deputy Tax Collector shall furnish all forms, envelopes, and postage necessary in the performance of its obligations during the term of this appointment. The Fox Chapel Area School District shall not be responsible for any payment of any charge other than as due to Jordan Tax Service, Inc.

18. APPLICABLE LAW. This Agreement shall be governed by the laws of the State of Pennsylvania.

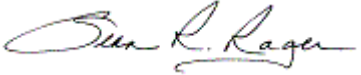
