Students may purchase no more than two tickets (one student admission & one guest admission) with approved contracts.

CONTRACT: The contract signed by you and your parent/guardian is required in addition to purchasing a ticket. This includes contracts from your guests as well.

DOORS CLOSE: Parents/Guardians of attendees who do not check-in by 8:30 PM will be called. No one will be allowed to leave before 10:30 PM. Once attendees have left, they will not be allowed re-entry.

DRESS CODE: Formal attire required. Dress appropriately. Tuxedos (not required) or dress suits (slacks, sport coat, dress shirt, tie, dress shoes) are acceptable attire. Formal gowns (floor length) or cocktail gowns (knee length) are acceptable attire. No dress/blouses with complete bare midriff. No undergarments may show. No excessive cleavage, high slits, or low backs. If your dress is too revealing as determined by an administrator, entrance may be denied. No jeans, sports attire, hats, "flip-flops," chains or canes allowed. Students and their guests will be checked for adherence to the dress code upon entrance to and during the dance. Students who fail to adhere to the proper dress code will

PICTURE ID: A current school picture ID is required in order to be admitted to the dance.

STUDENTS ON SUSPENSION: Students on suspension or who were transferred from their school site to another school for disciplinary reasons are not allowed to participate in the Winter Formal.

INAPPROPRIATE DANCING: Do not use positions or moves that are suggestive of sexual behavior or any other type of gesture or behavior that is provocative in nature. Inappropriate dancing may be grounds for removal from this event and participation in other senior activities. No dancing against walls.

PROM RULES AND REQUIREMENTS

WHO MAY ATTEND: This dance is open to LBUSD thematic high school students in grades 9-12 with approved contracts. Off-campus guests are allowed to attend this event as the guest of a LBUSD thematic high school student, provided that they have completed an "Off-Campus Guest" contract and they are currently enrolled in at least the 9th grade, and are not over the age of 20.

DRUGS, TOBACCO AND ALCOHOL: Possession or use of alcoholic beverages, tobacco, drugs, or narcotics before, during, or after the dance or in the parking lot adjacent to the dance site is strictly prohibited. Possession or use will result in the appropriate disciplinary action including but not limited to being ineligible to participate in other school sponsored activities, suspended/expelled from school and/or arrested by the Local Police Department. You and your guest, if suspected of being under the influence, will agree to a breathalyzer test before being admitted to or remaining at the dance.

ATTENDANCE POLICY:

1. You **MUST** be at school for the duration of the school day the day before the dance.
2. If you show up later than 9:00 AM or leave school early that day, you will not be allowed to attend the dance.
3. There will be no refunds for students that break the attendance policy the day of the event.

TICKET POLICY:

1. Tickets may be purchased on the Web store or from the Banker's Window. Tickets that are non-transferable may not be given, sold, or exchanged to other students.
2. No refunds will be issued for students that change their mind or no-show to the dance.
